Converter academy orders

Project: An application from Saint Pius X Catholic High School A Specialist School in Humanities, URN 106962, Rotherham, to convert and become an academy and join St Francis Catholic Multi Academy Trust.

Representations received:

No representations were made for this project.

AB advice:

- Saint Pius X Catholic High School A Specialist School in Humanities is a 650 capacity school located in Rotherham with 693 pupils on roll. The school was last inspected in April 2024 and is currently rated as Requires Improvement.
- Officials' assessment of the trust using the Commissioning High Quality Trusts
 Framework was considered alongside Saint Pius X Catholic High School A Specialist
 School in Humanities' strategic needs. In making the recommendation, consideration
 was given to the view of the Diocese of Hallam that St. Pius should move into St.
 Francis Multi-Academy Trust because it was best positioned to support the needs of
 St. Pius both academically and geographically. The trust has another school in the
 Local Authority which will provide school to school support.
- St Francis Catholic Multi-Academy Trust is encouraged to undertake work, on a trust-wide basis, to ensure that all current Local Academy Committees (LACs), and the local governing body at Saint Pius X Catholic High School A Specialist School in Humanities (which will become a LAC on conversion) fully understand their roles and responsibilities within the trust governance structure and Scheme of Delegation.
- Schools Funding and Strategic Oversight (SFSO) colleagues recommended the deployment of a School Resource Management Advisor (SRMA) to the trust post conversion.

Project: An application from Franklin College, URN 130586, North East Lincolnshire, to convert and become an academy and form a new trust called The Franklin College Trust.

Representations received:

• No representations were made for this project.

AB advice:

- Franklin College is a 2100 capacity sixth form college located in North East Lincolnshire with 2029 pupils on roll. It was last inspected in May 2024 and is currently rated as Outstanding.
- Officials' assessment of the new trust using the Commissioning High Quality Trusts
 Framework was considered alongside Franklin College's strategic needs and the
 needs of the local area. In making the recommendation, consideration was also
 given to Franklin College's intention to work positively in the system to strengthen
 and protect the opportunity for young people in the local area to access high quality
 post 16 provision. The proposal aims to strengthen the offer to all learners across
 the locality. The proposal received strong local stakeholder support.
- Board members agreed that the college has significant strength in post-16 education and were assured by Franklin College's detailed plan to support learners across the locality though Memorandums of Understanding and professional generosity.

Project: An application from Limpsfield Junior School, URN 107040, Sheffield, to convert and become an academy and join Cascade Multi Academy Trust.

Representations received:

• No representations were made for this project.

AB advice:

- Limpsfield Junior School is a 240 capacity school located in Sheffield with 225 pupils on roll. The school was last inspected in March 2022 and is currently rated as Good.
- Officials' assessment of the trust using the Commissioning High Quality Trusts
 Framework was considered alongside Limpsfield Junior School's strategic needs. In
 making the recommendation, consideration was given to the school working closely
 with Cascade Multi Academy Trust since the end of 2022 under a Service Level
 Agreement (SLA). This proposal seeks to formalise this relationship.
- Schools Funding and Strategic Oversight (SFSO) colleagues recommended the deployment of a School Resource Management Advisor (SRMA) to the trust post conversion. A consolidated forecast is also to be provided to aid forecasting.
- The board members considered the details of the project and did not raise any concerns in relation to the proposal.
- This project was considered along with Sharrow Nursery, Infant and Junior School.

Project: An application from Sharrow Nursery, Infant and Junior School, URN 134302, Sheffield, to convert and become an academy and join Cascade Multi Academy Trust.

Representations received:

• No representations were made for this project.

AB advice:

- Sharrow Nursery, Infant and Junior School is a 420 capacity school located in Sheffield with 428 pupils on roll. The school was last inspected in May 2024 and is currently rated as Good.
- Officials' assessment of the trust using the Commissioning High Quality Trusts
 Framework was considered alongside Sharrow Nursery, Infant and Junior School's
 strategic needs. In making the recommendation, consideration was given to the
 school having stated that they feel the trust's ethos and values align with their own
 and that they look forward to being able to collaborate with the trust more closely
 whilst not losing their own individual identity.
- Schools Funding and Strategic Oversight (SFSO) colleagues recommended the deployment of a School Resource Management Advisor (SRMA) to the trust post conversion. A consolidated forecast is also to be provided to aid forecasting.
- The board members considered the details of the project and did not raise any concerns in relation to the proposal.
- This project was considered along with Limpsfield Junior School.

Project: An application for St Patrick's Catholic Voluntary Academy, URN 139347, Sheffield, to transfer from St Patrick's Catholic Academy Trust to St Clare Catholic Multi Academy Trust.

Representations received:

No representations were made for this project.

AB advice:

- St Patrick's Catholic Voluntary Academy is a 280 capacity school located in Sheffield with 310 pupils on roll. The school was last inspected in Oct 2024 and of the five areas reviewed, the school was found to be inadequate in four areas (quality of education, behaviour and attitudes, leadership and management, and early years provision) and was found to require improvement in one remaining area (personal development).
- Officials' assessment of the trust using the Commissioning High Quality Trusts
 Framework was considered alongside St Patrick's Catholic Voluntary Academy's
 strategic needs. In making the recommendation, consideration was given to St Clare
 Catholic Multi Academy Trust being the best fit for the school of the diocesan options
 available.
- The trust is encouraged to continue to engage with Schools Funding and Strategic Oversight (SFSO) whilst the trust grows.
- Board Member's recommended that we continue to work with the trust to see how governance structures can be strengthened.
