These are threshold conditions which a regulated user-to- user service, search service or combined service under Part 3 of the OSA must meet in order to be designated by Ofcom as a Category 1, Category 2A, or Category 2B service in a published register and thereby be subject to additional duties under the OSA. The threshold conditions for Category 1 will also be used by Ofcom to prepare a list of emerging Category 1 services. Services will be placed on the emerging list if they meet the conditions set out in section 97 of the OSA. The draft was laid before Parliament on 16.12.24 and the SI was made on 26.02.25.
