Non-Technical Summary

This Noise and Vibration Monitoring Report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise monitoring carried out within Buckinghamshire (BS) during the month of March 2025.

Within this period monitoring was undertaken at the following worksites:

- Noise and vibration were undertaken in the vicinity of A422 Turweston North worksite (ref.: A422 TN), where overbridge construction, viaduct works and earthworks were underway.
- Noise and vibration were undertaken in the vicinity of School End (ref.: SE) and Hermitage Chetwode (ref.: HC), worksites where landscape bund construction, overbridge works, highway works, digging, compound dismantling, construction of temporary access road, site access and haul road maintenance and de-vegetation were underway.
- Noise and vibration were undertaken in the vicinity of Twyford worksite (ref.: TW), where viaduct works, stabilisation, material movements, stockpiling, site access and haul road maintenance and de-vegetation underway.
- Noise and vibration were undertaken in the vicinity of West Street Overbridge worksite (ref.: WSO), where commissioning, formwork reinforced concrete works, earthwork embankments and operation of overpumps were underway.
- Noise and vibration were undertaken in the vicinity of Calvert worksite (ref.: CAL), where production of concrete, material movements, earthworks and excavation were underway.
- Noise and vibration were undertaken in the vicinity of Woodlands worksite (ref.: WDL), where technical backfill, material movements and sheet piling were underway.
- Noise and vibration were undertaken in the vicinity of Quainton worksite (ref.: QAR), where no works were underway.
- Noise and vibration were undertaken in the vicinity of Oat Close worksite (ref: OC), where overbridge works, earthworks, excavation and construction of soil stabilisation area underway.
- Noise and vibration were undertaken in the vicinity of Waddesdon worksite (ref.: WAD), where formwork reinforced concrete works, piling and earthworks were underway.
- Noise and vibration were undertaken in the vicinity of Thames Valley Viaduct worksite (ref.: TVV), where formwork installation, lifting operations, installation of

satellite compound, formwork reinforced concrete works, earthworks, removal of platforms and construction of site access road were underway.

- Noise and vibration were undertaken in the vicinity of Risborough Road worksite (ref.: RR), where overbridge works, earthworks, drainage, boring and utility works were underway.
- Noise and vibration were undertaken in the vicinity of Aylesbury Golf Course worksite (ref.: GC), where road realignment, earthworks, culvert and utility works were underway.
- Noise and vibration were undertaken in the vicinity of Nash Lee Lane worksite (ref.: NLL), where overbridge works, concrete pours, constructing steelwork, reinforcement and formwork construction, utility works, installation of sumps, formation grading and shuttering were underway.
- Noise and vibration were undertaken in the vicinity of Wendover Green Tunnel worksite (ref.: WGT), where excavation, stoning, stockpile movements, access road construction, deliveries, pre-treatment works, temporary bridge construction, concrete pours, de-mobilisation, site access and haul road diversion, waterproofing, invert blinding, office construction, utility works, crane mobilisation and cast installation were underway.
- Noise and vibration were undertaken in the vicinity of Grove Farm worksite (ref.: GF), where stockpile movements, bund construction, excavation, monitoring and underbridge works were underway.
- Noise and vibration were undertaken in the vicinity of Small Dean Viaduct Compound worksite (ref.: SDVC), where completion of lowering, installation of bearings, abutment wall construction, installation of reinforcement and formwork, casting and backfilling were underway.
- Noise and vibration were undertaken in the vicinity of Rocky Lane Embankment worksite (ref.: RLE), where concrete pours, temporary installation works, steel work installation, shuttering, lifting operations, drainage works, pavement installation and utility works were underway.
- Noise and vibration were undertaken in the vicinity of Wendover Dean Viaduct worksite (ref.: WDV), where plank installation, reinforcement fixing, concrete pours, deck, utility and lifting works were underway.
- Noise and vibration were undertaken in the vicinity of Leather Lane worksite (ref.: LL), where capping beams, drainage works and concrete finishing works were underway.
- Noise and vibration were undertaken in the vicinity of South Heath worksite (ref.: SH), where earthworks, utility works, general site activities, overbridge construction,

ground investigation works, site access and haul road construction and operation were underway.

- Noise and vibration were undertaken in the vicinity of North Portal worksite (ref.: NP), where earthworks, utility works, general site activities, culvert works, overbridge construction, ground investigation works and site access and haul road construction and operation were underway.
- Noise and vibration were undertaken in the vicinity of Chesham Road worksite (ref.: CHSM), where general site activities, internal and external building works, demobilisation and landscaping were underway.
- Noise and vibration were undertaken in the vicinity of Little Missenden Vent Shaft worksite (ref.: LM), where site operation, tunnel connections, headhouse superstructure works and building construction were underway.
- Noise and vibration were undertaken in the vicinity of Amersham Vent Shaft worksite (ref.: AM), where site operation, external and internal building works, precasting of boundary wall, steel, cladding and drainage works were underway.
- Noise and vibration were undertaken in the vicinity of Chalfont St Giles Vent Shaft worksite (ref.: CSG), where site operation, road maintenance, demobilisation and internal and external building works were underway.
- Noise and vibration were undertaken in the vicinity of Chalfont St Peter Vent Shaft worksite (ref.: CSP), where site operation, road maintenance, demobilisation and internal and external building works were underway.
- Noise and vibration were undertaken in the vicinity of Colne Valley Viaduct worksite, which is partly located in the London Borough of Hillingdon (LBH), (ref.: CVV), where compound operations and demobilisation, access road construction, pumping water management, satellite compound welfare works, environmental maintenance, deck and landscaping works and general site works were underway.

The HS2 threshold levels for significant noise impacts, which are defined in Information Paper E23 (<u>https://www.gov.uk/government/publications/hs2-information-papers-environment</u>), were exceeded one (1) time during the reporting period.

One (1) exceedance of trigger levels as defined in Section 61 consents occurred during the reporting period.

One (1) complaint regarding noise and vibration was received by HS2 during the monitoring period.

| Decibel(s) A- weighted, or dB(A) | The human ear system does not respond uniformly to sound across the detectable frequency range and consequently instrumentation used to measure sound is weighted to represent the performance of the ear. This is known as the 'A weighting' and is written as 'dB(A)'. |
| Equivalent continuous sound pressure level, or L _{Aeq,T} | An index used internationally for the assessment of environmental sound impacts. It is defined as the notional unchanging level that would, over a given period of time (T), deliver the same sound energy as the actual time-varying sound over the same period. Hence fluctuating sound levels can be described in terms of an equivalent single figure value, typically expressed as a decibel level. |
| Exclusion of data | Measurement of noise levels can be affected by weather conditions such as prolonged periods of rain, winds speeds higher than 5m/s and snow/ice ground cover. Noise levels measured during these periods are considered not representative of normal noise conditions at the site and, for the purposes of this report, are excluded from the assessment of exceedances and calculation of typical noise levels and are also greyed out in charts. Identifiable incongruous noise and vibration events not attributable to HS2 construction noise are also excluded. |
| Façade | A facade noise level is the noise level 1m in front of a large reflecting surface. The effect of reflection, is to produce a slightly higher (typically +3 dB) sound level than it would be if the reflecting surface was not there. |
| Free-field | A free-field noise level is the noise level measured at a location where no reflective surfaces, other than the ground, lies within 3.5 metres of the microphone position. |
| LOAEL | Lowest Observed Adverse Effect Level – the level above which adverse effects on health and quality of life can be detected. |
| Peak particle velocity, or PPV | Instantaneous maximum velocity reached by a vibrating element as it oscillates about its rest position. The PPV is a simple indicator of perceptibility and risk of damage to structures due to vibration. It is usually measured in mm/s. |
| SOAEL | Significant Observed Adverse Effect Level – the level above which significant adverse effects on health and quality of life occur. |
| Sound pressure level | The parameter by which sound levels are measured in air. It is measured in decibels. The threshold of hearing has been set at 0dB, while the threshold of pain is approximately 120dB. Normal speech is approximately 60dB at a distance of 1 metre and a change of 3dB in a time varying sound signal is commonly regarded as being just detectable. A change of 10dB is subjectively twice, or half, as loud. |
| Vibration dose value, or VDV | An index used to evaluate human exposure to vibration in buildings. While the PPV provides information regarding the magnitude of single vibration events, the VDV provides a measure of the total vibration experienced over a specified period of time (typically 16h daytime and 8h night-time). It takes into account the magnitude, the number and the duration of vibration events and can be used to quantify exposure to continuous, impulsive, occasional and intermittent vibration. The vibration dose value is measured in m/s ^{1.75} . |

1 Introduction

- 1.1.1 HS2 is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under Section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring may be undertaken for the following purposes:
 - monitoring the impact of construction works;
 - to investigate complaints, incidents and exceedance of trigger levels; or
 - monitoring the effectiveness of noise and vibration control measures.
- 1.1.2 Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the Buckinghamshire (BS) Local Authority area for the period 1st to 31st March 2025.

2.2 Exceedances of the LOAEL and SOAEL

- 2.2.1 The lowest observed adverse effect level (LOAEL) is defined in the Planning Practice Guidance – Noise (PPG) as the level above which "noise starts to cause small changes in behaviour and/or attitude, e.g. turning up volume of television; speaking more loudly; where there is no alternative ventilation, having to close windows for some of the time because of the noise. Potential for some reported sleep disturbance. Affects the acoustic character of the area such that there is a perceived change in the quality of life".
- 2.2.2 The significant observed adverse effect level (SOAEL) is defined in the 'Planning Practice Guidance – Noise' as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in

difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area.

- 2.2.3 HS2 Phase One Information Paper E23: Control of Construction Noise and Vibration sets out the LOAELs and SOAELs for construction noise.
- 2.2.4 Where reported construction noise levels exceed the LOAEL and SOAEL at nearby receptors, relevant periods will be identified. Summary statistics to evaluate ongoing qualification for noise insulation and temporary rehousing are also presented where relevant.
- 2.2.5 Table 5 presents a summary of recorded exceedances of the LOAEL and SOAEL over the reporting period, including the number of exceedances during each time period.

- 2.2.6 Exceedances of the LOAEL were recorded at twelve (12) monitoring locations during the month of March 2025. LOAEL exceedances were recorded during weekday and Saturday daytime and evening, Sunday and night working periods.
- 2.2.7 For the purpose of reporting the number of days where the SOAEL is exceeded, multiple exceedances of the SOAEL in a 24-hour period would be counted as a single exceedance during that day. Over the reporting period, the overall number of SOAEL exceedances at each measurement location is shown in Table 6 and may be lower than the total sum of individual exceedances reported in Table 5 for each location.
