#### **Passport**

If this is your first application with the MCA, you will need to provide a copy of your passport's ID page.

#### **Training**

For your GOC/ROC, you will need to submit your GMDSS Course Completion Certificate

For your initial STCW Endorsement application, you will need to submit documentary evidence of having completed **MCA-approved** or **accepted** training within the previous 5 years for:

- Personal Survival Techniques (STCW Table A-VI/1-1);
- Fire Prevention and Fire Fighting (STCW Table A-VI/1-2);
- Elementary First Aid (STCW Table A-VI/1-3);
- Personal Safety and Social Responsibilities (STCW Table A-VI/14);

To revalidate your STCW Endorsement, you will need to submit documentary evidence of having completed **MCA-approved** or **accepted** updating-refresher training within the previous 5 years for:

- Personal Survival Techniques (STCW Table A-VI/1-1);
- Fire Prevention and Fire Fighting (STCW Table A-VI/1-2);

#### **Medical fitness**

Please see our list of MCA approved doctors for both <u>UK based</u> or <u>overseas doctors</u>. <u>MSN 1815 Amendment 6</u> contains a list of countries whose medical certificates are accepted as equivalent to the UK certificate.

DG Shipping India medicals must include 'Annexure IV – Medical Certificate for Service at Sea' page.

# 6. Payment

You must enclose the correct fee with your application. Please indicate your chosen method of payment. Payment must be made in pounds sterling (£).

There is no additional fee for revalidating GMDSS at the same time as your CoC.

If you are sending documents from outside the UK and indicate to your courier company that the documents have a value of over £100 GBP, you will be liable to pay any import charges.
