EXPORT OF DAY OLD CHICKS TO NEPAL

NOTES FOR THE GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

1. Scope of the certificate

This certificate covers the export of day old chicks of the domestic fowl (Gallus gallus) to Nepal.

2. Official Signature

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government, Welsh Government or the Department of Agriculture, Environment and Rural Affairs (DAERA) Northern Ireland, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

OVs must sign and stamp the health certificate with the OV stamp in any ink colour **OTHER THAN BLACK**.

Certified Copy Requirements - England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

if the exported commodity is cattle, pigs, sheep, goats or camelids;
if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other EHCs issued, however CITC may request certified copies of EHCs and supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

DAERA Export Health Certificates: Provision of certified copies

aPVPs certifying DECOL produced Export Health Certificates must return a legible, scanned copy of the final EHC to the relevant DAERA Processing Office within 1 working day of signing.

Good quality photographic copies will be accepted by the department, where obtaining a scanned copy is not feasible - for example, where 'on site' certification is undertaken and scanning facilities are not available.

For record purposes, a copy of the final Export Health Certificate and associated Support documents should be retained by the aPVP for a period of 2 years from the date of certification.

The Department will carry out periodic audits of all aspects of export certification to ensure that a high standard of certification is being maintained.

3. Notifiable disease

Paragraphs IV a) and b) refer. These paragraphs may be certified by the OV provided that they have received written authority (Form 618NDC) which will be sent to them by APHA Centre for International Trade, Carlisle, or DAERA in Northern Ireland before shipment. The exporter must provide detail of the premises of origin.

Authority will be given to certify (i) when no disease control zones are in place in the UK.

At times when the UK is affected by the stated disease, authority to certify (ii) will be given when the premises are not within any zone subject to disease control restrictions.

Alternatively, authority can be given to certify (iii) when all flock and hatchery premises are within an official compartment.

The OV must certify one of (i), (ii) or (iii) in each of a) and b), and delete those lines which do not apply.

4. Flock Health

Paragraphs IV c) and d) refer. The inspection must take place within 28 days prior to shipment. Evidence of disease should be understood to include clinical signs, data from flock mortality and production records, laboratory reports and pathological examinations.

Note that 'chronic respiratory disease' means infection with *Mycoplasma gallisepticum*.

5. Poultry Health Scheme

Paragraph IV e) refers. A government supervised poultry health scheme refers to the Poultry Health Scheme (PHS) in GB or the Northern Ireland Poultry Health and Assurance Scheme (NIPHAS) in Northern Ireland.

Membership of the PHS/NIPHAS may be certified on behalf of the Department provided the OV has received written authority (Form 618NDC) which will be sent by the APHA Centre for International Trade, Carlise, or from DAERA in Northern Ireland, before despatch. Note that the 618NDC form will confirm solely that the premises is a current scheme member, the OV is personally responsible for checking that testing has been carried out, and that all the laboratory results have been negative.

6. <u>Support Health certificate</u>

Paragraphs IV c), d), and e) refer. In cases where the OV is not personally responsible for the flock(s) of origin, they may certify the statements referring to those flocks on the basis of a support certificate (6440SUP) provided by the veterinarian who is regularly responsible for those flocks. The support health certificate will be provided at the same time as the export health certificate.

7. Disclaimer

This certificate is provided on the basis of information available at the time, and may not necessarily comply fully with the requirements of the importing country. It is the exporter's responsibility to check the certificate against any relevant import permit or any advice provided by the competent authority in the importing country. 8. Welfare of Animals during transport

Exporters and transporters must comply with all the legislation for the welfare of live animals during transport. The welfare conditions required during transport, are set out in Council Regulation EC No 1/2005 (as retained), implemented in England by The Welfare of Animals (Transport) (England) Order 2006, with parallel legislation in Scotland and Wales. If transported by air, animals should also be transported in accordance with International Air Transport Association (IATA) standards.
