Section 1 – Applications Received

A **statutory objector** may inspect a goods vehicle operator's licence or application under Regulation 9 of the Goods Vehicles (Licensing of Operators) Regulations 1995 by setting out their authority and requesting arrangements are made for inspecting the record by emailing – Environmental@otc.gov.uk

Objections against published applications may be made in writing by a Chief Officer of Police, a local authority, a planning authority or a prescribed trade union or association within 21 days of the date on which notice of an application is published in Applications and Decisions. Objections must be made either on the grounds that any of the requirements listed in Section 13 of the Goods Vehicles (Licensing of Operators) Act 1995 are not met and/or that a nominated operating centre will be unsuitable for use as such. A copy of the objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector.

Classification of Operator Licences – There are three classes of licence:

- A **Restricted (R)** licence authorises the use of a goods vehicle on public roads in Great Britain for the carriage of the licence holder's own goods in the course of his trade or business. The licence holder cannot carry goods for other people for hire or reward;
- A **Standard National (SN)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward, on public roads in Great Britain. He can also carry his own goods on journeys abroad;
- A **Standard International (SI)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward. These activities can be undertaken both in Great Britain and on international journeys.

Summary of Original TC Decision – S13 - Application refused This application to approve Walnut Hill Nursery as an operating centre is refused because: a) the proposed operating centre is not available as required by Section 13 (5) of the Goods Vehicles (Licensing of Operators) Act, 1995. b) the proposed site is unsuitable because the use as an operating centre would adversely affect the environment in the vicinity on the grounds of noise, visual intrusion and vibration. The application to increase the number of vehicles authorised on the licence is granted subject to a maximum of ten vehicles. The upgrade of the licence to a standard national is also granted The interim licence in force allowing the use of Walnut Hill Nursery as an operating centre and authorising fourteen vehicles is extended until the 16 June 2025 when it will terminate and the refusal of the application in relation to the operating centre and the reduction in vehicle numbers will take effect.

Tribunal Appeal Number – UA-2025-000637-T

Grounds for Appeal – Disagree with DTC conclusions. The finding of unavailability is disputed because no final planning decision had been made at the time. Challenge the environmental concerns, which were based largely on anecdotal accounts from a single neighbouring household.
