# What is Bereavement Support Payment?

This is a tax free benefit based on your late partner's National Insurance (NI) contributions. By your partner we mean either your husband, wife, civil partner, or partner that you lived with as if you were married to them, at the time of their death.

## Can I get Bereavement Support Payment?

You may be able to get Bereavement Support Payment if your late partner died on or after 6 April 2017, and at the time of death:

- you were under State Pension age
- you were:
  - married or in a civil partnership with the person who died, or
  - you were living with the person who died as if you were married and you had dependent children who were under the age of 20, or
  - you were living with the person who died as if you were married and you were expecting a child
- your late partner paid enough National Insurance contributions, and
- you ordinarily lived in the UK or a country with which we have a reciprocal agreement to pay certain UK benefits.

If your late partner died before 6 April 2017 go to the 'More information' section of these notes.

If you are still not sure if you can get Bereavement Support Payment, claim anyway.

# How much could I get?

Bereavement Support Payment is paid to you as a one off, lump-sum payment followed by up to 18 monthly payments. You may not get the lump-sum payment and you may get fewer than 18 monthly payments depending on when you claim and when you reach State Pension age.

There are 2 rates of Bereavement Support Payment.

**Higher rate** - this is made up of:

- a lump-sum payment of £3,500, and
- up to 18 monthly payments of £350.

**Standard rate** - this is made up of:

- a lump-sum payment of £2,500, and
- up to 18 monthly payments of £100.

## Who can get the higher rate

You may be able to get the higher rate of Bereavement Support Payment if:

- you were entitled to Child Benefit when your late partner died
- you were expecting a child when your late partner died.

If you or your late partner were in the High Income Child Benefit Tax Charge group and you have not claimed Child Benefit, you must do so for your claim for the higher rate of Bereavement Support Payment to be considered. If your late partner was claiming Child Benefit and you have not yet made a claim to transfer it to your name, you must do so for your claim for the higher rate of Bereavement Support Payment to be considered. We are sorry to have to ask you some questions about your late partner.  
We need to ask these questions because Bereavement Support Payment is  
affected by their National Insurance contributions.

If you have any difficulty filling in this claim form, someone else can  
help you do it. You can ask a friend, relative or an advice centre such as  
Citizens Advice. Or ask at your local Jobcentre Plus.

## **When to claim**

You should send us the completed claim form BSP1 as soon as possible.

# More about Bereavement Support Payment

## **Is Bereavement Support Payment affected by earnings?**

No. Bereavement Support Payment is not means tested.

This means if you work, your Bereavement Support Payment will not go down because of the money you earn.

## **Will Bereavement Support Payment affect any benefits I get?**

No. Bereavement Support Payment will not have an impact on any other benefits you get. In the longer term, any other benefit you get might be affected if you have not spent your Bereavement Support Payment.

You must tell us about your Bereavement Support Payment if you apply for another benefit.

## **Is Bereavement Support Payment taxable?**

No. All payments are tax free.

## More information

If your late partner died before 6 April 2017 and you were expecting a child or had dependent children under 20 years old when they died, you may be able to get Widowed Parent's Allowance. ### **EEA and Swiss nationals need to have an EU Settlement Scheme status**

The United Kingdom (UK) has left the European Union (EU). If you are a European Economic Area or Swiss national, you and your family members need to get a UK immigration status to carry on living in the UK after 30 June 2021.

You and your family need a status even if you have already been issued with a permanent residence document by the Home Office, or have been living in the UK for a long time. You need to apply for an immigration status to be eligible for benefits. This includes new and existing claims to benefits.

It is free to apply for a UK immigration status. Irish nationals and those with indefinite leave to remain in the UK do not need to apply.

You do not need to contact DWP when you apply or get a status. If DWP need details about your status they will contact you.
