Table of Delegated Authorities for the Criminal Legal Aid (General) Regulations 2013

The below tables set out the authorisations given pursuant to section 6, for the purposes of section 5(2) and section 5(4), of the Legal Aid, Sentencing and Punishment of Offenders Act 2012, in relation to functions of the Lord Chancellor and the Director of Legal Aid Casework under each part of the Criminal Legal Aid (General) Regulations 2013 (S.I. 2013/9)

There are two tables for PART FIVE (Representation for criminal proceedings):

- 1. A PART FIVE table for applications for a representation order in the magistrates' court and Youth Court for summary only offences, either way offences and prescribed proceedings where both (i) and (ii) apply:
 - i. the individual is:
 - (a) a child (an individual who is under the age of 18 on the date on which an application is made for a determination under section 16 of the Act), or
 - (b) on a passported benefit, or
 - (c) unemployed (means is not employed, self-employed, a director or is living off savings, and, where applicable, their partner is also not employed, self-employed, a director or is living off savings).

The incidental proceedings under representation orders for magistrates' court and Youth Court proceedings issued by Providers under their delegated functions are the same as those under representation orders issued by the Legal Aid Agency and include committals for sentencing from the magistrates' court to the Crown Court.

- ii. a determination is being made in accordance with the Criminal and Civil Legal Aid (Amendment) Regulations 2025, including the transitional arrangements therein.
- 2. A PART FIVE table for all other applications for a representation order in the magistrates' court and Youth Court and for all applications for a representation order in the Crown Court (including where a Provider has granted a representation order in the magistrates' court under their delegated functions and the case is then sent to the Crown Court for trial).

There are two PART FIVE tables because who is authorised to exercise the functions of the Director of Legal Aid Casework in respect of representation orders in the magistrates' court and Youth Court is dependent upon the type of offence/proceeding and the individual's financial resources.
