JUDGMENT (Rule 22)

- 1. The claim was presented in the Watford Employment Tribunal on 8 October 2024. The respondent has failed to present a valid response on time. The Employment Judge has decided that a determination can properly be made of the claim or part of it in accordance with Rule 22 of the Rules of Procedure.
