You requested the following information:

The above block of flats owned by Diamond Corporation Ltd was converted into social housing. The landlord has now served a S21 eviction notice on all tenants but my real enquiry is how much funding were they granted and under what conditions.

Response

We can confirm that Homes England does not hold the information detailed in your request.

To conclude that the information is not held, we have searched with our Historical Grants team who would have the requested information if held.

To comply with this duty we are able to confirm that Homes England does not hold a funding agreement with Diamond Corporation Ltd for properties at [REDACTED]. We can confirm that Homes England provided £300,000 of funding to Omega Housing Ltd in June 2014 for the lease and repair of 15 properties at [REDACTED] with an expected lease period of 10 years.
