Thank you for your request for information which was processed in accordance with the Environmental Information Regulations 2004.

You requested the following information:

Could you please send me a map of the land owned by Homes England in and around the south Warrington area which is included in the new Warrington Local Plan and those areas which are excluded from the local plan but still within the south Warrington designated area.

<u>Response</u>

We can confirm that we do hold the requested information. Please see the map below which shows land owned by Homes England in and around the South Warrington area.

Regulation 9(1) provides that an authority must provide advice and assistance to applicants and in accordance with this we can advise the included key highlights whether land owned is freehold or under contract. In the areas highlighted as Pewterspear, Grappenhall and Appleton, where residential development is ongoing or has completed, the map indicates the number of freehold transfers that have now been made to plot purchasers.

Right to Appeal
