1. How many Help to Build equity loans have been issued since the scheme's launch in June 2022. Please provide a quarterly or monthly breakdown.
2. How many of these loans were for custom build and how many for self build homes?
3. Which areas of the country were the loans issued to?
4. What is the total value of the loans issued, and the number of starts/completions of homes using the loans?

To comply with this duty we are able to confirm that no Help to Build equity loans have been issued since the scheme's launch in June 2022. We can advise Help to Build equity loans are only drawn down when the build is complete. It can take up to two years from application to drawing down of the equity loan.
