I understand that £8.8million has been granted from the Oxfordshire Housing and Growth Deal to the Oxpens River Bridge in central Oxford. Please could you provide any documentation you have around this - for example, the basis on which funds were provided and how they meet the Growth Deal criteria, any applications for this funding, or notices regarding the funding decision, as well as any correspondence with Oxford City Council or Oxfordshire County Council on the use of Growth Deal funds for the bridge.

Response

We can confirm that Homes England does not hold the information detailed in your request.
