Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

My local authority is Hastings Borough Council. The addresses are	West Hill Road, St
Leonard's On Sea, East Sussex, TN38	

Applications may have been made anytime between 2011 to 2022. The most likely dates are 2013, 2014, 2019 and 2022, but I am unclear, since the authority's records are rather haphazard.

The type of application would be for projects such to erect affordable homes, mixed-ownership property, later-living property, leisure facilities and a hotel on the site.

There may have been other types of development plans for the sites that are not apparent to me at the moment.

### <u>Response</u>

We can confirm that Homes England does not hold the information detailed in your request. This is because there is no legal or business reason for Homes England to do so.

To conclude that the information is not held, we have searched with our Affordable Housing team who would have the requested information if held.
