RE: Request for Information – RFI4907

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

How many loans for funding have been allocated from the Home Builders Fund between October 2023 and the end of September 2024?

- Please give the number of loans
- The total allocated
- The number of homes that will be delivered from these loans
- How long each loan took to be approved

• Please separate the number and total value of those loans made for homes from those made for infrastructure work.

• Please also give information on how long each loan took to be decided, i.,e. either approved or rejected. By this, I mean the time in days between an application being lodged and a letter/email being dispatched to the applicant. Please break this information down into the standard 12 economic regions of the United Kingdom.

<u>Response</u>

We can confirm that we do hold the requested information. Please be advised the Home Building Fund/Levelling Up Home Building Fund and Home Building Fund Infrastructure Loans are the follow-on funds from the Home Building Fund for housing development and infrastructure works. They are loans, rather than grants, and the information included in this response relates to recoverable loans.

Please be advised we rely on section 43(2) of the FOIA to withhold some of the information from disclosure.

Section 43 - Commercial interests

Under section 43(2) Homes England is not obliged to disclose information that would, or would be likely to, prejudice the commercial interests of any party.

The information requested relating to two of the loans engages section 43(2) of the FOIA as it is commercial in nature and its release would be likely to prejudice the commercial interests of Homes England and other interested parties to the information.

Homes England has identified that the information requested, if released, would be likely to prejudice the effective operation of our funding schemes.

Section 43 is a qualified exemption. This means that once we have decided that the exemption is engaged, Homes England must carry out a public interest test to assess whether or not it is in the wider public interest for the information to be disclosed.

Arguments in favour of disclosure:

- Homes England acknowledges there is a general public interest in promoting accountability, transparency, public understanding and involvement in how Homes England undertakes its work and how it spends public money.
- Homes England acknowledges that there is a public interest in large scale development processes and the robustness of the applications for funding submitted to the Home Building Fund/Levelling Up Home Building Fund.

Arguments in favour of withholding:

• If this information were to be released it would be likely to disadvantage Homes England's and the third party's commercial position and have a negative impact on ongoing discussions. This would also be likely to have the same negative effect on future commercial activity and other Homes England funding. This would not be in the public interest as it would put future developments at risk, inflate prices and damage Homes England's reputation as a partner;

- Disclosure would result in house builders being deterred from including commercially sensitive information in future bids for grant funding. This will mean that Homes England would have to evaluate bids that are less comprehensive than would otherwise have been the case, meaning that Homes England's ability to undertake due diligence on the bids will be impaired. This would impact the ability of Government officials to make effective, informed decisions regarding allocation of public funds, meaning the decisions will be less robust and less likely to deliver value for money;
- The requested information relates to current and ongoing projects where all opportunities have not yet been determined or concluded. The disclosure of this information into the public domain could therefore disrupt the progress and put the projects at risk; and
- Homes England has been unable to identify a wider public interest in disclosing the information requested.

Having considered the arguments for and against disclosure of the information, we have concluded that at this time, the balance of the public interest favours non-disclosure for this information.

Our response is detailed below:

How many loans for funding have been allocated from the Home Builders Fund between October 2023 and the end of September 2024?

(a) Please give the number of loans

A total of 40 loan applications contracted between 1 October 2023 and 30 September 2024. This breaks down into 2 infrastructure projects and 38 housing development projects.

(b) The total allocated

This equates to £219.6m in loans on Infrastructure and £237.7m on housing development loans.

(c) The number of homes that will be delivered from these loans

These loans are anticipated to deliver 22,150 units of unlocked housing capacity and 5,645 homes.

(d) How long each loan took to be approved

This question is addressed as part of section (f).

(e) Please separate the number and total value of those loans made for homes from those made for infrastructure work.

We have outlined the detail above based on loans made for homes and those made for infrastructure work.

(f) Please also give information on how long each loan took to be decided, i.,e. either approved or rejected. By this, I mean the time in days between an application being lodged and a letter/email being dispatched to the applicant. Please break this information down into the standard 12 economic regions of the United Kingdom.

In the period between 1 October 2023 and 30 September 2024, 40 loan projects contracted and a further 30 projects were approved. 182 projects withdrew during the due diligence process as they were ineligible for funding and a further 172 projects were withdrawn as the prospective borrower ceased communication with us. No projects were formally rejected.

Annex A below contains a table which sets out the number of working days it took from origination to approval for each of the contracted projects.

Annex B below contains a table which sets out the number of working days it took from origination to approval for each of the approved contracts.

Annex C below contains a table which sets out the number of working days it took from origination to withdrawal for each of the withdrawn projects, as well as the reason for withdrawal. Please note, 22 project applications had not provided information on geographic location at the point of withdrawal and are noted as '0' in the Economic Region column.
