## RE: Request for Information – RFI4968

Thank you for your request for information which was processed in accordance with the Environmental Information Regulations 2004 (EIR).

You requested the following information:

Further to my recent request to know how homes under the proposed 10% (supported housing) of the overall AHP programme have been built and how many are still available for allocation.

I would like to know how many supported housing homes have been built in Kent to date and also how many are marked as approved to be built In Kent.

## **Response**

We can confirm that we do hold the requested information.

We can confirm 1,017 homes have been allocated for delivery in Kent under the 2021-26 Affordable Homes Programme via the Continuous Market Engagement route, of which 148 are for Older Persons Shared Ownership (OPSO) and supported housing (14.6%). Of the 148 OPSO and supported homes 9 have been delivered up to 31 March 2024 (6.1%).

For the Strategic Partnerships element of the 2021-26 programme we don't hold a breakdown of OPSO and supported housing delivery by county, only Government region. 190 OPSO and supported housing homes have been allocated in the South East region, of which 50 have been delivered up to 31 March 2024 (26%).

You may also complain to the Information Commissioner's Office (ICO) however, the Information Commissioner does usually expect the internal review procedure to be exhausted in the first instance.
