We can confirm we use the Sprout Social platform.

3) What is your annual spend on a Social media management tool?

We can confirm that the annual cost is \$21,377.96 (this equates to £16,903.58 at today's exchange rate)

4) What dates does your contract with your current supplier end (in the format of [month/year])? We can confirm our current contract ends in January 2026

5) Do you use a social listening / media monitoring platform?

We can confirm we do use a media monitoring platform.

6) If so, what tools do you use?

We can confirm we use Cision as a media monitoring platform.

7) What is your annual spend on a social listening / media monitoring tool?

We can confirm that the annual spend is £19,000.

8) What dates does your contract with your current supplier end (in the format of [month/year])?

We can confirm our current contract ends in January 2027.

9) Who is the senior person responsible for managing these contracts?

We can inform you that we do hold the information that you have requested. However, we rely on Section 40 (2) of the FOIA to withhold the information from disclosure.

Section 40 – Personal information

We are withholding information on the grounds that in constitutes third party personal data and therefore engages section 40(2) of the FOIA.

To disclose personal data, such as names, contact details, addresses, email addresses and personal opinions could lead to the identification of third parties and would breach one or more of the data protection principles.
