Thank you for your recent email, which was processed under the Environmental Information Regulations 2004 (EIR).

You requested the following information:

Please could you tell me if you own any ponds or lakes as part of your land holding portfolio. If so, please could you supply details of their location.

Response

Regulation 12(4)(a) – Information not Held

Under regulation 12(4)(a) of the EIR, Homes England may refuse to disclose information if the requested information is not held by that public authority.

When relying on Regulation 12(4)(a), Homes England must also advise details of any other public authority to whom the requestor could redirect their request to, and in accordance with this we can advise that as part of our land holdings portfolio, we do own land across England that has a water feature on the land. Please see enclosed Annex A which contains a list of partial postcodes where a water feature is located

Regulation 9(1) provides that an authority must provide advice and assistance to applicants and in accordance with this we can advise that the software that we use to record information about our land holdings does not include a feature to determine which water body was a pond or lake. We have therefore used the descriptions on the link below to filter how the location is represented.
