#### Response

We can confirm that we do hold the requested information. We will answer your questions in turn below.

## 1 cost of all original signs

We can confirm the original signs cost £1,500 in March 2022. In addition, overlay stickers for the signs were later supplied at a cost of £212.23 in November 2022.

### 2 cost of all replacement signs

We can confirm that replacements signs cost £1,506.25 in February 2023. Further replacement signs cost £3,160.80 in March 2024.
