Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

I would like to know the basic details of any grants to for-profit registered providers since 2021:

- * Name of provider**
- * Amount of grant**
- * Date of award**
- * Tenure of housing supported by grant (social rent, affordable rent, shared ownership, etc)**

Response

We can confirm that we do hold some of the requested information. Please see enclosed Annex A, which contains a breakdown of the grant awarded to not-for-profit organisations requested from the 2021-22 to the 2023-24 financial year. The figures are based on completion year as that is the only common reporting period for Continuous Market Engagement and Strategic Partnerships. We can advise that the £0 values indicate that no grant was received by these providers.

Please note, we are withholding the data for 2024-25 financial year under the below exemption as this cannot be published until after the national statistics for that year are published at the end of June.

Section 44 – Prohibitions on Disclosure

Section 44 (1)(a) FOIA exempts information from disclosure if its disclosure is prohibited by other legislation. In this case, release of some of the information you are seeking is prohibited by the Statistics and Registration Services (SRS) Act 2007 and the Pre-release Access to Official Statistics Order 2008.

Data for 2024-25 will form part of the 'Housing Statistics' National Statistics publication routinely published every six months and cannot be provided until the data has been formally approved and officially published.

We are required to consider your request in a manner compliant with the Pre-release Access to Official Statistics Order 2008 further to sections 11 and 13 of the SRS Act 2007. These sections require producers of official statistics to ensure that no indication of the substance of a statistical report is made public or given to the media or any other party not recorded as eligible for access prior to publication. Although the information requested is not intended for publication in the exact form requested, to provide the information would constitute an 'indication' of the statistics due to be published in the 'Housing Statistics' National Statistics publication as they form part of a subset of published data.

Therefore, to disclose the information at this date would cause Homes England to violate the provisions of section 13 of the SRS Act 2007 and the Pre-Release Access Order to Official Statistics 2008 and as such the exemption under section 44(1)(a) of the FOIA is engaged.

Section 44 is an absolute exemption which means that we do not have to consider the public interest in disclosure.

Advice and Assistance

We have a duty to provide advice and assistance in accordance with Section 16 of the FOIA. As such we can advise that the data for the 2024-25 period is expected to be published at the end of June 2025, though this is not certain. The Section 44 exemption will apply until this publication date and therefore we advise you submit any future requests after this date.

Right to Appeal

If you are not happy with the information that has been provided or the way in which your request has been handled, you may request an internal review. You can request an internal review by writing to Homes England via the details below, quoting the reference number at the top of this letter.
