Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

I am submitting a Freedom of Information request regarding a development for which full planning permission approval was granted on 17th August 2004 by London Borough of Newham to London & Quadrant Housing Trust (L&Q) under the name 'Grove Crescent Road & Angel Lane, Former Maryland Works London, E15 1BJ', and for which a Section 106 agreement was made between London Borough of Newham and London & Quadrant Housing Trust on 20th June 2006 under the name 'Site known as Maryland Works, 20-22 Grove Crescent Road, Stratford, London E15 1BJ'. I believe the development was completed in 2007 or 2008 although I am not certain of this....

- 1. Were the costs of procuring or developing the properties in this development partly paid for by any of the following: Social Housing Grant, Social Housing Assistance, or Disposal Proceeds Fund?
- 2. Were the costs of procuring or developing these properties partly paid for by any other grant from Homes England or its predecessors (Homes & Communities Agency or the Housing Corporation)? If so, what was the name and nature of the grant?
- 3. If yes to either questions 1 or 2, did this funding apply to all or only part of the development? If only part, which parts? Are particular buildings or units specified as 'units that attract SHG' and 'units that do not attract SHG'?
- 4. Has any other grant funding been provided at any time by Homes England or its predecessors (Homes & Communities Agency or the Housing Corporation) in relation to this development, and if so what was the name and nature of this grant funding, and did it apply to all or parts of this development?
