## RE: Request for Information – RFI5136

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

I'm writing to request information under the Freedom of Information Act in relation to the Kitchener Barracks development in Chatham, Kent. The developer J G Chatham Limited, responsible for delivering Kitchener Barracks, entered administration in September 2024.

Please may you respond to the following:

- 1. Can you confirm that Homes England's total lending to J G Chatham Limited, in respect of Kitchener Barracks, amounts to £28,502,888?
- 2. Was Homes England's lending to J G Chatham publicly, taxpayer-funded? If not, how was the lending funded?
- 3. Has Homes England recovered any amount of the £28,502,888 from J G Chatham Limited to date?
- 4. Is the abovementioned lending arrangement separate to the THBF (Short Term Fund) grant of £7,638,070 contracted to J G Chatham Limited in 2016?

## **Response**

We can confirm that we do hold the requested information. We will address each of your questions in turn below.

1. Can you confirm that Homes England's total lending to J G Chatham Limited, in respect of Kitchener Barracks, amounts to £28,502,888?

We can confirm that this is the amount that Homes England as secured creditor was owed at the date of the appointment of administrators.

2. Was Homes England's lending to J G Chatham publicly, taxpayer-funded? If not, how was the lending funded?

We can confirm that the lending was funded through The Home Building Fund – Short Term programme.

**3.** Has Homes England recovered any amount of the £28,502,888 from J G Chatham Limited to date? We are able to confirm that Homes England have not recovered any funds to date.

4. Is the abovementioned lending arrangement separate to the THBF (Short Term Fund) grant of £7,638,070 contracted to J G Chatham Limited in 2016?

We can confirm that the abovementioned lending arrangement is separate to THBF grant. We can advise that Homes England registered a charge (debenture) dated 1 July 2016 which was satisfied in full on 26 February 2018.
