About this document

This document, produced by MHCLG in collaboration with ONS, presents high-level data to support the Plan for Neighbourhoods programme. It is intended to support Neighbourhood Boards in both identifying and evidencing local needs or trends. It does not make policy recommendations.

Background

- **On 4 March 2025, the UK Government announced the launch of the Plan for Neighbourhoods. This will provide up to £20 million in support and funding for 75 places across the UK over the next decade.**
- Data is presented across broad themes that Neighbourhood Boards may consider addressing through the programme.
- This pack does not take account of the implementation of current national or local policy interventions.


Data caveats

- The data sources in this pack are the latest available as of 1st April 2025. In collaboration with the Office for National Statistics (ONS), we have derived metrics at the Settlements (2015) geographical level, where this data was not previously available. Estimates are at Settlement (2015) level unless stated otherwise. **These are experimental estimates for small levels of geography that may be more volatile or have higher levels of uncertainty, which should be taken into consideration when interpreting the data.** The metrics in this pack do not account for any boundary request changes submitted by places.
- Gross Value Added (GVA) per filled job data was not available for this Settlement. This is due to a significant decrease in the data quality of GVA estimates for Settlements with a population less than 25,000 people.
- Due to data availability, estimates at local government district level are based on geographic boundaries as of 2024. Coleraine is within the local government district of Causeway Coast and Glens.

This data pack defines a neighbourhood's boundary based on the definition of Settlements (2015), unless stated otherwise. This reflects the default approach for the Plan for Neighbourhoods. The metrics in this pack do not account for any boundary changes submitted by the Neighbourhood Boards.



Overview of indicators

This page provides an overview of how the Settlement's indicators (listed in the Annex) for policy investment themes fare against national averages.



The chart on the left shows how Coleraine's indicators (orange) fare against national averages (dark blue). Settlement values have been scaled relative to the national averages which were set to 100.

How to read the chart:

1. Compare the overall shape of the Settlement data points to the national average shape.
2. The closer a Settlement marker is to value 100 on the chart, the closer it is to the national average. For example, a Settlement value of 150 means that it is 50% higher than the national average.

* The purpose of the [Living Environment Domain](#) is to identify, at the [Small Area](#) level, the prevalence of shortcomings in the quality of housing, access to suitable housing, and the outdoor physical environment.







** Anonymised and aggregated mobile network data by Virgin Media O2. Footfall is defined as the average daily number of outbound journeys (not including journeys to home) within the Settlement over the period April 2022-March 2023. The mean average footfall of Settlements in Northern Ireland with populations similar to Coleraine (+/- 30%) has been standardised to an index of 100. The number for Coleraine is scaled relative to this average.



Population (16+) that are economically inactive, by reason (%) (2021)






Method of travel to work (%) (2021)






Demographics

Headlines:


- In 2021, the median age in **Coleraine was 41 years**. The median age for Northern Ireland was 39. The median age for Causeway Coast and Glens was 42 years.
- The median age in Coleraine **increased** by 3 years between 2011 and 2021. For context, the median age in Northern Ireland increased by 2 years over the same period (*see top chart*).
- In 2022, Coleraine had a population **of 24,603**. Between 2011 and 2022, Coleraine's **population decreased by 0.1%**. For context, the population increased by 0.3% in Causeway Coast and Glens and increased by 5.5% in Northern Ireland.
- In 2021, 18.8% of people in Coleraine were under 16 years old, and 19.2% were aged 65 and over. For context, the Northern Ireland average was 20.4% and 17.2%, respectively (*see bottom chart*).
- Across Coleraine in 2021, 97.3% of people identified with a White ethnic group and 2.7% with a minority ethnic group.




Deprivation

Headlines:

- In 2017, over 30% of [Small Areas](#) in Coleraine were in the **top 20% most deprived in Northern Ireland in terms of Employment Domain, Income Domain, and Crime and Disorder Domain.**
- Income Domain (18.2%) and Employment Domain (16.7%)** were the domains that had the largest proportion of Coleraine's Small Areas in the **top 10% most deprived in Northern Ireland.**
