# MHCLG: Local Government Reorganisation Advisory Group – Terms of Reference

#### **Overview**

The Local Government Reorganisation (LGR) Advisory Group has been established by the Ministry of Housing, Communities and Local Government to support the delivery of the government's LGR programme. The group brings together senior leaders and experts from across local government to provide advice on policy development, implementation, and risk management.

While its primary focus is on reorganisation, the group also considers related issues such as devolution, where relevant.

#### **Purpose**

The Advisory Group plays a key role in:

- Offering evidence-based recommendations to inform policy and delivery.
- Providing constructive challenge to the implementation of the LGR programme.
- Sharing insights and best practice from past and current reorganisation.
- Highlighting emerging risks and suggesting mitigations.
- Advising on how government can best support local authorities through change.

The Group's advice helps ensure that the LGR programme is delivered effectively and in a way that supports wider public service reform in partnership with the sector.

#### Governance

The Group operates within the governance structure of the LGR programme. Its advice is shared with the programme board, which may also seek the Group's views on strategic issues. While the government is not obliged to act on the Group's advice, it will be considered carefully to support effective delivery.

#### **Membership**

The Group includes representatives from key local government organisations, councils with direct experience of reorganisation and sector experts. Members typically hold senior leadership roles, such as Chief Executive, and contribute based on their expertise and experience.

The Group is chaired by the Directors of Local Government Reform and Strategy at MHCLG.

### **Meetings**

The group meets monthly, either online or in person. Meetings are supported by a secretariat and include the production of action notes. Members may also be consulted outside of meetings as needed.
