THE EAST ANGLIA ONE NORTH OFFSHORE WIND FARM ORDER 2022 AND THE EAST ANGLIA TWO OFFSHORE WIND FARM ORDER 2022: PARAGRAPH 4 OF PARTS 1, 2 AND 3, SCHEDULE 18 – GUARANTEES IN RESPECT OF COST OF COMPENSATION MEASURES

- 1. Thank you for your email dated 3 June 2025 providing draft Parent Company Guarantees ("the Guarantees") to the Secretary of State regarding East Anglia One North Limited, and East Anglia Two Limited ("the Applicant") obligations under Paragraph 4, Part 1, 2 and 3 of Schedule 18 to the East Anglia ONE North Offshore Wind Farm Order 2022 and the East Anglia TWO Offshore Wind Farm Order 2022 ("the Orders"). The Applicant is the undertaker for the purposes of the obligations under Paragraph 4, Part 1, 2 and 3 of Schedule 18 to the Orders.
- 2. Paragraph 4, Part 1, 2 and 3 of Schedule 18 to the Orders requires the following: "The undertaker must not commence the authorised development unless it has first
  - (a) provided a reasonable estimate of the cost of delivery of the compensation measures; and
  - (b) put in place either—
  - (i) a guarantee in respect of the reasonable estimate of costs associated with the delivery of the compensation measures; or
  - (ii) an alternative form of security for that purpose,
  - that has been approved by the Secretary of State."
- 3. The Secretary of State has considered the estimate of the cost of delivery of the compensation measures provided by the Applicant on 28 May 2025 and is satisfied. The Secretary of State has considered the two Guarantees made on 25 July 2025 between Scottishpower Renewables (UK) Limited ("the Guarantor"), East Anglia One North Limited, and East Anglia Two Limited (each

- "the undertaker" for their respective Guarantees) and the Secretary of State. The Secretary of State is satisfied with the two Guarantees provided.
- 4. The Secretary of State therefore gives his approval that each undertaker has fulfilled its obligation under Paragraph 4, Part 1, 2 and 3 of Schedule 18 to the Orders in a suitable form of security to cover the Kittiwake compensation measures, Lesser black-backed gull compensation measures, and Redthroated diver compensation measures.
