# **Summary**

This is a summary of UK legislation in food and feed law and related scientific and regulatory issues for the period from 28 March to 24 June 2025. Other relevant technical updates are listed thereafter.

#### **Primary GB legislation.**

#### Secondary GB legislation.

<u>The Food (Promotion and Presentation) (Wales) Regulations</u> 2025 set out restrictions on the promotion and presentation of specified food products. The foods to which these regulations apply to are defined, as are the business types including on-line businesses. The regulations are also available in Welsh.

<u>The Genetic Technology (Precision Breeding) Act 2023 (Commencement No. 1) Regulations 2025</u> bring into force certain provisions of the Genetic Technology (Precision Breeding) Act 2023.

The Genetic Technology (Precision Breeding) Regulations 2025 introduce detailed requirements for the release of precision bred organisms (PBO's). The regulations require the applicant to provide specified information including details of the organisation responsible for the PBO, a description of the organism, details of the intended genetic changes including how they alter the characteristics of the PBO. The regulations also provide for a precision breeding register. The regulations also prohibit the placing on the market food produced from PBO's where certain conditions are not met, including having authorisation for the PBO, meeting any conditions within the authorisation and the PBO has a 'history of safe use'.
