## **REQUIREMENT TO WARN**

To: Haier Smart Home UK & I Ltd ('**you**') (Registered company number: 02521528)

Of: 302 Bridgwater Place, Birchwood, Warrington, WA3 6XG

The Office for Product Safety and Standards ('**OPSS**') acts as the Secretary of State to enforce the General Product Safety Regulations 2005 ('**the 2005 Regulations**').

This Notice is served under regulation 13 of the 2005 Regulations.

This Notice has effect throughout the United Kingdom.

### **PART A - Description of Products**

This Notice applies to all Heat Pump Tumble Dryers that have been modified as part of Haier's original corrective action programme ('**Products**'), comprised of:

## **PART B - *Grounds for Service***

- OPSS considers you are the producer of the Products.
- OPSS has reasonable grounds to believe that the Products are dangerous products, in that they could pose risks for certain persons.
- OPSS considers the Products pose a risk of fire as it is possible for an internal short circuit to occur within the Products during normal use. This can cause the Products to ignite, causing a fire.
- OPSS considers that from the information presently available, including the Corrective Action Plan records you have provided:
  - some Products have not been modified to a satisfactory standard; and
  - in some instances, it is not possible to determine whether Products have been modified effectively.
- Due to the urgency these circumstances present, it is not feasible for OPSS to provide you with an opportunity to formally submit your views in advance of serving this Notice.

## **PART C - *Action Required***

In respect of the Products, you are required to do the following, at your own expense:

- (1) Where and to the extent it is practicable to do so, inform all persons who could be subject to the risks referred to in Part B, as well as those persons to whom you have supplied the Products that:
  - The Products present a risk of fire that could result in death or injury.
  - They should stop using the Products.
  - They should contact the manufacturer.

This should be communicated immediately, and in a format appropriate to the circumstances of the persons who could be subject to the risks referred to in Part B, as well as those persons to whom you have supplied the Products.

- (2) Publish warnings on your business websites and external consumer communications which include clear information about the risks the Products present, the advice to stop using the Products and contact the manufacturer. This should be published immediately.

## **PART D - *Consequences of non-compliance***

It is an offence (regulation 20(4) of the 2005 Regulations) to contravene or to fail to comply with a requirement imposed by this Notice. A person guilty of an offence is liable:

- On summary conviction, to a fine or to imprisonment not exceeding three months, or to both.
- On conviction on indictment, to a fine not exceeding £20,000 or imprisonment for a term not exceeding twelve months, or to both.

## **PART E - *Rights of Appeal***

You (or another person having an interest in the product to which this Notice relates) have the right to appeal this Notice. You may apply for an order to vary or set aside the terms of this Notice within 21 days, beginning with the day on which this Notice is served.

Any such application may be made by way of complaint to any magistrates' court in England, Wales or Northern Ireland, or by summary application to the sheriff in Scotland.


