# **Minutes**

#### **Welcome and introductions**

Louise Morgan, newly appointed Director for Freight and Borders, introduced herself and expressed enthusiasm for working with the Council. She highlighted her previous experience in the department and her involvement in strategic decisions, including the Spending Review.

The Minister for the Future of Roads welcomed attendees and emphasised the strategic importance of freight and logistics to the UK's economy, decarbonisation goals, and regional development.

## **Introductory remarks from the Minister**



The Minister outlined the government's strategic priorities, including the role of freight in delivering the UK's five missions. She referenced the recently published Industrial Strategy and highlighted major investments such as £25.3bn for HS2 and £590m for the Lower Thames Crossing.

The Minister emphasised regional equity, decarbonisation, and the importance of freight in supporting public services and economic growth.

# **Discussion with the Minister: Freight Council priorities**

Isabel commenced the discussion by providing an overview of the workshop conducted with Members the day prior. In this workshop, the Council reaffirmed its purpose: to collaborate across modes and supply chains, identify priority areas, and influence policy and investment.

Key principles identified:

- Focus on impactful, cross-sectoral initiatives.
- Leverage the Council's diversity to amplify collective voice.
- Avoid duplication with existing initiatives.
- Working groups and a forward programme of meetings will be established to drive progress.

Isabel introduced each of the priority areas in turn, inviting the designated Member to elaborate on their respective topic, before resuming the chair to lead the ensuing discussion.

## **Key Priority Areas Identified**

# 1) Raising Awareness and Advocacy

<u>Objective:</u> Develop a unified narrative to elevate freight's visibility across government. Promote the concept of the 'goods experience' akin to the passenger experience. Highlight freight's role in innovation, safety, and economic growth.

# 2) Infrastructure and Network Provision

<u>Objective:</u> Create a multimodal infrastructure map identifying bottlenecks and priorities. Align industry and government views on future investment needs. Emphasise both new infrastructure and optimisation of existing network.

## 3) Decarbonisation Roadmap

<u>Objective:</u> Understand the relevant activity taking place on the transition to net zero, including bridging fuels and power supply. Explore place-based solutions (e.g., logistics hubs, ports). Coordinate with DESNZ and other departments and key players on energy infrastructure to scope potential to influence.



# 4) Trade and Borders

<u>Objective:</u> Reframe border issues around growth and resilience. Advocate for digitalisation and AI to reduce friction.

# 5) Planning and Regulation

<u>Objective:</u> Push for consistent application of the National Planning Policy Framework (NPPF) and continue to influence future planning reform to secure enhanced freight provisions. Address local authority engagement and last-mile connectivity.

## 6) Employment and Skills

<u>Objective:</u> Promote logistics as a driver of social mobility and regional employment. Collaborate on workforce development and training initiatives, joining forces with the Freight Workforce Group where appropriate.

# **New Freight Plan Update**

Laura provided a short update on the internal stakeholder engagement being undertaken by the DfT to inform the new Freight Plan. Online workshops will be held in July to gather industry input.

Laura reiterated that the end product will be a short, action-oriented document and aligned with Council priorities. Publication is expected later in the year.

Council Members (particularly trade associations) were encouraged to champion participation by promoting the workshops to relevant members.

## **Closing Remarks**

The Minister and Louise Morgan thanked attendees for their engagement. Emphasis was placed on maintaining momentum and delivering impact. The meeting concluded with a commitment to continued collaboration and progress.

# **Key Decisions and Outcomes:**

## 1. Working Group Formation

Members agreed to form working groups around each priority area to develop actionable plans, with some volunteers identified.

## 2. Commitment to Cross-Government Engagement

There was strong support for engaging other departments (e.g., HMRC, DBT, HMT) to ensure freight is integrated into broader government strategies, especially around borders and energy.

# 3. New Freight Plan

Council Members were encouraged to champion participation in the stakeholder engagement workshops scheduled over the summer to inform the development of the new Plan. The New Freight Plan team also committed to providing an



update on key findings from the engagement undertaken and next steps at the next meeting.

# 4. Measures of Success Defined

The Council agreed to define success in terms of:

- Freight considered in cross-government strategies and decisions.
- Improved productivity and reduced regulatory burdens.
- Increased private investment enabled by public sector clarity.
- Tangible progress on decarbonisation and infrastructure delivery.

## 5. Next Steps

- 1.1: Isabel to circulate next steps via email, and with support from DfT coordinate working group to commence development of work programme for each identified priority area.
