About

Part 1 – Application Status Table

An application status table, showing the status with which an LGBT Financial Recognition Scheme and an explanation.

Status of Application	Explanation
Initial Application Check	
Initial Application Check Phase	This phase starts 2 weeks after the submission of the application, when the application is locked down for changes. An applicant can only make minor amendments to their application (such as changes to personal details).
Starting Initial Application Check	This phase checks the application to confirm the identity of the applicant and confirm that the evidence supplied is in a readable format. This phase also includes the call for MOD archived Service records and where necessary, MOD held medical documents (where consent has been given). The phase concludes with the creation of the case file for the applicant.
Initial Application Check – Awaiting Information from Applicant	During the initial application check, the check will be paused should the Scheme reach out to the applicant for information or further evidence required to complete the initial application check.
Initial Application Check - Passed or Initial Application Check - Not Served During the Ban	
Dismissed or Discharged (DD) Payment	
DD Payment Application – Eligibility Check Phase	Post the Initial Application Check Phase, a DD eligibility check is undertaken.
DD Payment Application – Awaiting Information from Applicant	During the DD Payment Processing Phase, the eligibility check will be paused <u>should</u> the Scheme reach out to the applicant for information or further evidence required to complete the DD Payment Processing Phase.
DD Decision Letter Issued – Awaiting Response from Applicant	For successful applicants for a DD payment, a DD Decision letter is issued. This invites the applicant to accept the DD payment and confirm their bank

	account details. The Scheme will pause for the applicant to respond.
DD Payment - Decision Accepted	The applicant has replied to the Scheme, accepted the FR Payment and has confirmed the bank account details which they wish the payment to be made to.
DD Payment – Payment Action Taken	The Scheme has initiated the action for the FR payment to be made to the applicant. Payment should be received within 30 working days.
Intention to Raise an Appeal Request – DD Payment	The applicant has not accepted the FR Payment and has indicated that they wish to raise an Appeal Request. Appeal Requests are raised via a separate process.
Impact Payment	
Preparing Case for Independent Panel	The Independent Panel (IP) Secretariat are preparing the casefile for review by the Independent Panel.
Preparing Case for Independent Panel - Awaiting Information from Applicant	During the preparation phase, the process will be paused <u>should</u> the Scheme reach out to the applicant for information or further evidence.
Application Booked to an IP Sitting	The IP Secretariat has booked the case file into an IP Sitting date. This date still could be subject to change. Impact Payment Determination Outcome letters will be issued within 30 working days of the IP sitting date.
Impact Payment Determination Outcome Letter issued	The IP have made their determination and have issued an Impact Payment Determination Outcome letter which has been sent to the applicant. The Scheme will pause for the applicant to respond.
Impact Payment Determination Outcome accepted	The applicant has replied to the Scheme, accepted the FR Payment and has confirmed the bank account details which they wish the payment to be made to.
Impact Payment – Payment Action Taken	The Scheme has initiated the action for the FR payment to be made to the applicant. Payment should be received within 30 working days.

Intention to Raise an Appeal Request – Impact Payment	The applicant has not accepted the FR Payment and has indicated that they wish to raise an Appeal Request. Appeal Requests are raised via a separate process.
Appeals	
Appeal Request Submitted	The applicant has raised an Appeal Request to the Scheme.
Appeal Request Accepted	The Appeal Request is confirmed as meeting one or more of the Appeal criteria.
Appeal Request Booked to an Appeal Board Sitting Date	The Appeal Board (AB) Secretariat has booked the case file into an AB Sitting date. The Appeal Judgement Letter will be issued within 30 working days of the AB sitting date.
AB Judgment Letter Issued	The AB has made its determination and have issued an AB Judgment letter to the applicant. This judgement will either uphold the original decision/determination or decide a new judgement.
New AB Judgment Accepted by the Applicant	The applicant has accepted the new AB judgment as detailed in the AB Judgment Letter.
New AB Judgment – Payment Action	The Scheme has initiated the action for the new AB judgement payment to be made to the applicant. Payment should be received within 30 working days.
Other	
Hold Notice Given – 2 month Review Point.	Applicant has been given notice that a permanent hold may be placed on the processing of the application if they do not respond to request(s) for information. The first review point is 2 month point without any contact.
Consideration of Placing the Application on Permanent Hold – 4 month Review Point	Applicant has been made aware that a permanent hold will be placed on the processing of their application if they do not respond to request(s) for information. The second review point is at the 4 month point without any contact from the applicant.
Application Placed on Permanent Hold – 6 month Review Point	Application has been placed on permanent hold (processing of their application has been stopped) due to the applicant not responding to questions asked by the Scheme including requests

	for information from the applicant. The last review to be undertaken at the 6 month point.
All FRS actions complete.	All actions with respect to the application for FR payment(s) have been completed.

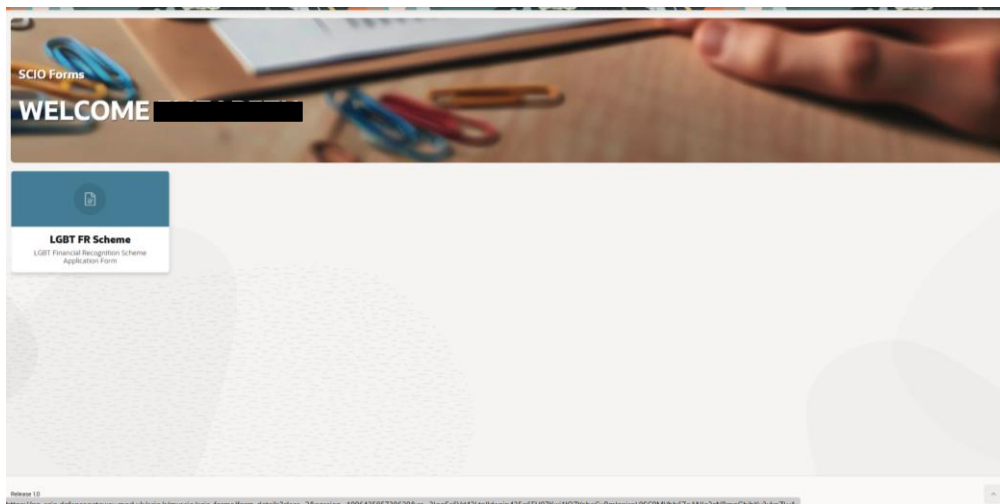

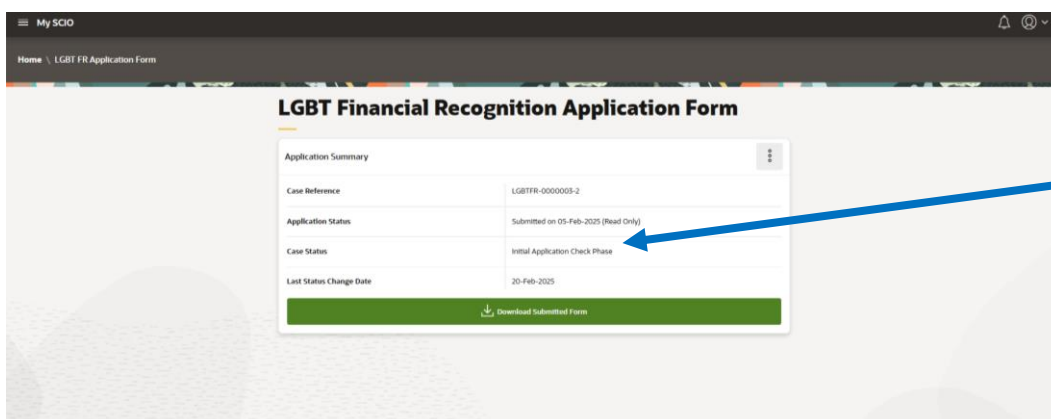
Part 2 – How to find the Status of my Application for Online Applicants

Part 1 of this document contains details about the status and gives an explanation against each status type.

It is difficult to provide an exact timeline for when Financial Recognition payments will be received by applicants, as it depends on the payment(s) applied for and the ease of accessing the supporting evidence. The Scheme is processing applications, except for those prioritised in accordance with the Scheme Rules, in submission date order.

The details about how online and hard copy applicants (with a communications preference of email) will be updated by automated emails when their status changes can be found in Parts 4 and 5 below.
