DECISION No 1/2025 OF THE GEOGRAPHICAL INDICATIONS SUB-COMMITTEE UNDER THE STRATEGIC PARTNERSHIP, TRADE AND COOPERATION AGREEMENT BETWEEN THE UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND AND THE REPUBLIC OF MOLDOVA

of 18 July 2025

on the amendments to Annexes XIII-C and XIII-D on geographical indications

THE GEOGRAPHICAL INDICATIONS SUB-COMMITTEE,

Having regard to the Strategic Partnership, Trade and Cooperation Agreement between the United Kingdom of Great Britain and Northern Ireland and the Republic of Moldova¹, and in particular Articles 276(4)(b) and 268(1) thereof,

Whereas:

- (1) The Agreement entered into force on 31st July 2023.
- (2) Within the framework of the Geographical Indications Sub-Committee, the United Kingdom of Great Britain and Northern Ireland² and the Republic of Moldova³ proposed names from the United Kingdom and from the Republic of Moldova respectively to be protected as geographical indications⁴ under the Agreement and be added in Annexes XIII-C and XIII-D to the Agreement.
- (3) Article 276(4)(b) of the Agreement provides that the Geographical Indications Sub-Committee shall be responsible for amending Annexes XIII-C and XIII-D to the Agreement as regards geographical indications.
- (4) Pursuant to Article 276(3) of the Agreement, the Geographical Indications Sub-Committee must adopt its decisions by consensus.
- (5) Following the request of the Parties and pursuant to Article 268(1) of the Agreement, the United Kingdom has completed the opposition procedure and the examination of 10 additional GIs of the Republic of Moldova and the Republic of Moldova has completed the opposition procedure and the examination of 11 additional GIs of the United Kingdom.
- (6) The United Kingdom has requested that the entry relating to "Scottish Farmed Salmon" be omitted from the list in Annex XIII-C to the Agreement and an entry relating to "Scottish Salmon" be included in that list instead following the change of name of that protected GI under the relevant United Kingdom Government GI scheme and the Republic of Moldova has

- published the amended information regarding that amended name and completed the relevant procedures.
- (7) For the purpose of clarification, the United Kingdom has requested that the entries relating to "White Stilton cheese / Blue Stilton cheese", "Kentish ale and Kentish strong ale", "Gloucestershire cider/perry", "Herefordshire cider/perry" and "Worcestershire cider/perry" (each of which cover two GI names and not one) be omitted from the list in Annex XIII-C to the Agreement and separate entries relating to "Blue Stilton Cheese", "Gloucestershire Cider", "Gloucestershire Perry", "Herefordshire Cider", "Herefordshire Perry", "Kentish Ale", "Kentish Strong Ale", "White Stilton Cheese", "Worcestershire Cider" and "Worcestershire Perry" be included in that list instead.
- (8) Consensus having been reached by the Geographical Indications Sub-Committee about the amendments of the relevant GIs lists in Annex XIII to the Agreement, Annexes XIII-C and XIII-D to the Agreement should be amended as provided for by this Decision.

HAS ADOPTED THIS DECISION:

Article 1

- 1. Annexes XIII-C and XIII-D to the Agreement are amended as follows:
- 2. In Annex XIII-C:
 - (a) in the first table relating to UK GIs:
 - (i) omit the rows relating to:
 - (aa) Scottish Farmed Salmon;
 - (bb)White Stilton cheese / Blue Stilton cheese;
 - (cc) Kentish ale and Kentish strong ale;
 - (dd) Gloucestershire cider/perry;
 - (ee) Herefordshire cider/perry;
 - (ff) Worcestershire cider/perry;
 - (ii) at the end insert the additional rows in Annex 1;
 - (b) in the second table relating to Moldovan GIs, at the end insert the additional rows in Annex 2.
- 3. In Annex XIII-D:
 - (a) in Part A:
 - (i) in the first table relating to UK GIs, at the end insert the additional rows in Annex 3;
 - (ii) in the second table relating to Moldovan GIs, at the end insert the additional row in Annex 4;
 - (b) in Part B;

- (i) in the first table relating to UK GIs, at the end insert the additional row in Annex 5;
- (ii) in the second table relating to Moldovan GIs, at the end insert the additional row in Annex 6.

Article 2

This Decision shall enter into force on 25 July 2025.
