







# Subsidised camelid parasitology testing

Miscellaneous & Exotic Farmed Species (MEFS) Expert Group August 2025

APHA is offering subsidised worm egg and coccidial oocyst counting for camelids until 30 June 2026.

### Camelid worm egg and coccidial oocyst counting

The test offered by APHA:

- is discounted to £7 per sample (from £30.06 per sample)
- follows the Sensitive Improved Modified McMaster method (TC0860)
- is a two-part process including saturated sodium chloride and saturated zinc sulphate floatation, which enables the detection of all significant nematode eggs and coccidia oocysts, including *Eimeria macusaniensis, Eimeria ivitaensis, Trichuris* species and *Nematodirus* species
- is sensitive to 10 eggs or oocysts per gram of faeces
- requires at least 4.5g of faeces (a heaped tablespoon)

### How to send samples

Submit samples either:

- through the Animal Disease Testing Service, using the free postage label generated
- directly to APHA's <u>Carmarthen Veterinary Investigation Centre</u> with a <u>general</u> submission form

#### You must:

- submit the samples through a veterinary surgeon
- indicate whether the samples are for monitoring or diagnostic purposes

 ensure the packaging conforms with postal regulations for Category B biological substances (<u>UN3373</u>) - do not submit samples in gloves

## Other parasitology tests offered by APHA

APHA also offer discounted:

- fluke and camelid worm egg count package (PC0864)
- differential staining for *Haemonchus* species eggs (<u>TC0777</u>) this test is exclusively carried out by APHA, which enables prompt testing of worm egg count samples submitted to us
