If you are a probate practitioner do not complete this form. You must provide an affidavit/ statement of truth and exhibits to lead to a R54 NPCR 1987 order to prove a copy of the will.

Please answer all the questions in detail and as best as you can and forward your completed form back to the Probate Registry. Please use the box provided at the end of the questionnaire if you require extra space.

Further information may be needed once the form has been considered by the Probate Registry especially in complex cases and where there are persons prejudiced as per question 14.

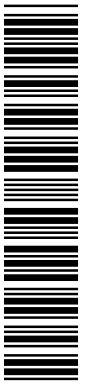

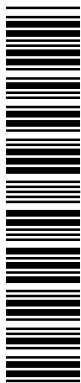

Please include details of anyone else who would be able to give evidence to support this.

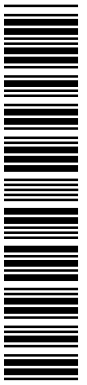

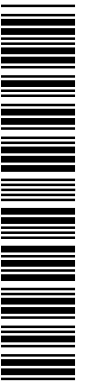

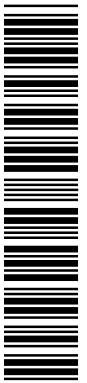
