The sum of £190.00 per calendar week will be registered as the fair rent with effect from 19 August 2025, being the date, the Tribunal made the Decision.

SUMMARY REASONS

Background

1. Following an objection from the Landlord to the determination of a fair rent by the Rent Officer, the Tribunal has made a determination under the provisions of the Rent Act 1977.
2. The parties did not request a hearing or inspection to determine this matter and the Tribunal agreed with this arrangement and considered this case on the basis of the papers provided by the parties and the Rent Officer with the assistance of Rightmove and Google Maps.

Evidence

3. The Tribunal did not receive completed Reply Statements from the parties or evidence of market rents in the area. The Tribunal had before it, the Rent Officers two Registrations and calculations for the most recent registration on the 3 February 2025.

Determination and Valuation

4. Having consideration of the Landlords evidence and our own expert, general knowledge of rental values in the Mortlake area, we consider that the open market rent for the property in its current condition would be in the region of **£505** per calendar week. From this level of rent we have made adjustments in relation to:

Terms of tenancy, no white goods, no carpets and curtains, central heating system installed by tenant, kitchen and sanitary fittings installed by tenant. This equates to approximately 35%

5. The Tribunal has also made an adjustment for scarcity at 20%
6. The full valuation is shown below:

Decision

7. The uncapped fair rent initially determined by the Tribunal, for the purposes of section 70, was **£262.60.** per calendar week. The capped rent for the property according to the provisions of the Rent Acts (Maximum Fair Rent) Order 1999 is calculated at £190.00 per calendar week. The calculation of the capped rent is shown on the decision form.

8. In this case therefore the lower rent of £190.00 per calendar week is to be registered as the fair rent on this property.
