- The Regional Director gave some general national and regional updates and invited feedback from the board.
- The board heard updates on the Regional Improvement for Standards and Excellence (RISE) team.
- The board considered Ofsted judgement outcomes for the previous month.

### Bedfordshire

#### Converter academy orders

**Project: An application from Wilstead Primary School [URN: 109492], Bedfordshire, to convert and become an academy and join Heart Academies Trust.**

#### Trust Changes

**Project: An application for Goldington Green Academy [URN: 139523], Bedfordshire, to transfer from Goldington Green Academy to Heart Academies Trust.**

#### Representations received:

- No representations were made for this project.

#### AB discussion:

- The board heard Wilstead Primary School is a mixed, local authority-maintained primary school, while Goldington Green Academy operates as a single academy trust (SAT). Both schools are located in Bedford and are geographically close to Heart Academies Trust.
- Both schools currently have Ofsted good ratings.
- Wilstead Primary School and Goldington Green Academy are aligned with the values and ethos of Heart Academies Trust.
- Heart Academies Trust has been working closely with Goldington Green Academy to strengthen its financial position and governance structures.
- The board reviewed performance data for the schools and Heart Academies Trust and discussed the trust's school improvement strategy.
- Wilstead Primary School will act as a capacity giver to Heart Academies Trust, owing to its strong educational outcomes.
- The voluntary conversion of Wilstead Primary School and the transfer of Goldington Green Academy to Heart Academies Trust should bring strategic alignment and long-term sustainability.

## Central Bedfordshire

### Trust Changes

**Project:** An application for Redborne Upper School and Community College [URN: 136559], Bedfordshire, to transfer from Redborne Upper School and Community College to The Pyramid Schools Trust.

**Representations received:**

- No representations were made for this project.

**AB discussion:**

- Redborne Upper School and Community College is a single academy trust (SAT) located in Ampthill, Bedfordshire.
- The board noted that Redborne Upper School and Community College has an established relationship with The Pyramid Schools Trust, with both sharing a common educational ethos.
- The Pyramid School Trust's central team has been expanded to support growth.
- The Pyramid Schools Trust appears to have strong financial management, which would support the effective operational management of Redborne Upper School and Community College.
- The board was informed that the voluntary transfer would be beneficial in broadening the post-16 curriculum offer.
- The Pyramid Schools Trusts is working with the local authority on its transition from a three-tier to a two-tier education system.

## Peterborough

### Trust Changes

**Project:** An application for Woodston Primary School [URN: 146843], Orton Wistow Primary School [URN: 146845] and Nene Valley Primary School [URN: 146854], Peterborough, to transfer from OWN Trust to Meridian Trust.

**Representations received:**

- No representations were made for this project.

#### **AB discussion:**

- The board heard that the OWN Trust consists of three primary schools, all based in Peterborough.
- The board was informed that this is a voluntary application to close the OWN Trust and transfer the three primary academies to the Meridian Trust.
- The board heard that the CEO of OWN Trust has resigned, and the trust is currently being led by an off-payroll CEO.
- The board noted that the OWN Trust would benefit from transferring its academies to a trust like Meridian Trust, which operates in the same local area and can provide strong and stable leadership.
- The board reviewed the educational outcomes of the Meridian Trust.
- The board heard that there are existing links between the two trusts, and the transfer would enable Meridian Trust to build a regional primary hub in the area.
- The board was reminded of the recent growth approved at a previous Advisory Board meeting and informed that the trust has experience in handling a transfer of this scale.
