# references to standards for radio equipment in support of the Radio Equipment Regulations 2017 (S.I. 2017/1206)

- 1. This notice sets out proposals that:
- (a) The references to the standards listed in Annex I to this notice be published for the purposes of regulation 2A of S.I. 2017/1206 in accordance with paragraph(2) below, and that the list of published standards set out in Annex I to notice 0119/25 be amended in accordance with Annex I to this notice.
- (b) The references to standards listed in Annex II to this notice (which have previously been published for the purposes of regulation 2A of S.I. 2017/1206), be removed from publication from the date set out in that Annex and the list of references for removal from publication set out in Annex II to notice 0119/25 be amended in accordance with Annex II to this notice. Accordingly, each such standard would not be designated, or give rise to any presumption of conformity, on or after the date set out in respect of it.

The references to standards are proposed to be published and accordingly designated under regulation 2A of S.I. 2017/1206 at 00.01 on the 29th day beginning with the date of this notice, unless this notice is withdrawn or amended before that date. Restriction 1: This designated standard does not address emission requirements in frequency bands below 9 kHz and does not therefore confer a presumption of conformity as regards this parameter in this band.

Restriction 2: This designated standard does not confer a presumption of conformity to the essential requirement set out in regulation 6(2) of S.I. 2017/1206, if its clause 6 is applied.
