Section 1 – Applications Received

A **statutory objector** may inspect a goods vehicle operator's licence or application under Regulation 9 of the Goods Vehicles (Licensing of Operators) Regulations 1995 by setting out their authority and requesting arrangements are made for inspecting the record by emailing – Environmental@otc.gov.uk

Objections against published applications may be made in writing by a Chief Officer of Police, a local authority, a planning authority or a prescribed trade union or association within 21 days of the date on which notice of an application is published in Applications and Decisions. Objections must be made either on the grounds that any of the requirements listed in Section 13 of the Goods Vehicles (Licensing of Operators) Act 1995 are not met and/or that a nominated operating centre will be unsuitable for use as such. A copy of the objection must be sent by the objector to the applicant at the same time that it is sent to the Traffic Commissioner. The onus of proof in terms of the grounds on which an objection is lodged lies with the objector.

Classification of Operator Licences – There are three classes of licence:

- A **Restricted (R)** licence authorises the use of a goods vehicle on public roads in Great Britain for the carriage of the licence holder's own goods in the course of his trade or business. The licence holder cannot carry goods for other people for hire or reward;
- A **Standard National (SN)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward, on public roads in Great Britain. He can also carry his own goods on journeys abroad;
- A **Standard International (SI)** licence allows the licence holder to carry both his own goods and goods for other people for hire or reward. These activities can be undertaken both in Great Britain and on international journeys.

- b) a professional body (e.g. IoTA/ CILT/ SOE/ IRTE);
- c) an approved examination centre offering the relevant transport manager CPC qualification for the type of licence held; or
- d) a firm of solicitors (or their associated training organisation) with significant experience with road transport regulatory and compliance issues (defined as having represented road transport operators and/or transport managers in at least 20 public inquiries over the past two years).

Virtual online courses must satisfy the criteria for such courses established by the traffic commissioners. Whether attending in person or participating in an online course, proof of attendance must be uploaded to the licence record via the Vehicle Operator Licensing self-service account within seven days of the course taking place.

If the attendee does not have a self-service account, the certificate must be emailed to notifications@vehicle-operator-licensing.service.gov.uk within seven days of the course taking place.

The criteria for virtual operator licence management (OLAT) courses are:

- the instructor and all course participants must be visible to each other and audible throughout the training;
- participants must participate by means of a tablet, laptop or PC with the necessary camera/microphone capability. Participation by smartphone is not acceptable unless it has the full functionality of the larger devices;
- the course provider must be able to verify the identity of all participants and do so before the course commences;
- the instructor must be able to interact with participants, display material and discuss it simultaneously;
- the course must replicate as far as is possible the training which would have been delivered in a physical environment.
- there must be some element of assessment at a point or points during the training, to verify that participants have actively engaged in the course;
- while the virtual element of the course need not last 7 hours, total participation time for each attendee (including prior reading, completion of "homework" modules etc) should be in this region.

Section 3 – Schedule 4 Applications

Schedule 4 to the Goods Vehicles (Licensing of Operators) Act 1995 allows, in certain situations, the transfer of operating centres from one existing licence to either another existing licence or as part of a new licence application. A range of qualifying criteria has to be met, with approval at the Traffic Commissioner’s discretion. An important consideration in the process is any environmental history relating to the subject operating centre or any potentially adverse environmental impact resulting from the transfer. Legislation prevents any statutory objection against the Schedule 4 element of an application.
