Live service wants your opinion

The 2025 Live Service survey is now live. Local authorities that have already migrated are invited to take part. The survey link has been issued by Relationship Managers. To ensure we get a full picture, we encourage you to share the survey with other departments that are involved with the Local Land Charges Programme.

Your feedback will help us to ensure that users get the best possible live service experience. Following the first survey last September, we made improvements to the Live Service Handover Pack, created the Quality Response Tracker, introduced the Application Processing Interface Continuity Action Plan and more. API port access is changing

The port that the application programming interface (API) currently connects to is changing from Port 3000 to Port 433 on 13 October 2025.

What do I need to do?

Your IT teams will need to update the current maintain API URL from:

maintain-Ilc.landregistry.gov.uk:9000 to

api.maintain-llc.landregistry.gov.uk

The location of API URL fields will vary by supplier.

You will need to whitelist both IP addresses below, if you haven't already done this. These addresses are in addition to the current IP addresses you hold for HM Land Registry.

If you do not update your API URL before 13 October, you will not be able to access your application API.

All API users have received two email updates regarding this change. If you have any questions about this change, please contact your Relationship Manager.



The Ministry of Housing, Communities and Local Government Property Data Pilot update

HM Land Registry (HMLR) recently launched a pilot on behalf of The Ministry of **Housing, Communities** and Local Government (MHCLG). Together, we are exploring whether digitalising and enhancing access to building regulations and highways data can improve the home buying and selling process.

We will work with the nine authorities below, who represent a diverse range of structures, such as county, district, unitary, metropolitan and London Borough councils – spanning urban and rural locations:

- Caerphilly County Borough Council
- City of London Corporation
- East Devon District Council
- Leicestershire County Council
- London Borough of Enfield
- Medway Council
- Sefton Metropolitan Borough Council
- Stockport Metropolitan Borough Council
- West Sussex County Council

HMLR will provide ongoing support to each of the participants throughout the pilot. In parallel we will work with a group of customers who are involved in different stages of the home buying and selling process. This work will help us to better understand how any changes may impact their experience.

Help improve the transparency of land or option agreements

HM Land Registry is developing a new digital service to improve the transparency of land or option agreements, also known as contractual control agreements. These agreements give prospective buyers the exclusive right to buy the land, without imposing any obligation to do so. This initiative is part of the Levelling Up and Regeneration Act 2023 and supports wider reforms to increase visibility of land ownership and contractual agreements.

To ensure the service meets user requirements, we are inviting local authority planning teams to take part in research sessions. These sessions will inform service development and ensure it supports planning functions effectively. Please **contact our researcher** to get involved.

Online research sessions will take 60 minutes and involve:

- Answering questions about your role and planning responsibilities
- Explaining the impact of agreement information on decision making
- Exploring ways to best access agreement information for your needs.

When the service is launched local authorities will be able to:

Enhance planning processes by identifying land subject to contractual controls quickly Improve forecasting of development and infrastructure requirements Avoid planning delays.

Your voice matters, help us to build a tool that works for you and your community, by sharing your requirements and any concerns.



Implementation of API continuity action plan

On 18 August 2025, the Application Programming Interface (API) continuity action plan was introduced for API users in live service. The plan ensures that our customers can continue accessing land and property information in the event of a technical API issue. Local authorities (LAs) who use an API as their primary method to update the Local Land Charges Register will be provided with access to the Maintain User Interface (UI) to continue registering, amending and cancelling charges until the **API** issue is resolved.

How are issues monitored?

Relationship Managers are constantly monitoring LA registration volumes and API activity. If no charges have been registered for seven working days, the Relationship Manager will contact the LA to check if there is a problem. If a problem exists it will be assessed, and we will support the LA to resolve it.



What happens if an issue is identified?

If a technical issue has been identified and is not resolved by day 21, the Relationship Manager will provide the LA with Maintain UI access and training guides to allow a smooth transition from the API to UI Maintain if needed.

If by close of play on day 28 the issue persists, the API Continuity Action Plan will be invoked from day 29.

When the problem has been resolved, the Relationship Manager and the HMLR technical team will work with the LA to re-synchronise the register to ensure the service returns to its previous state.

Digital Planning Improvement Fund: Open for applications

Transform your planning services through digital innovation with the Ministry of Housing, Communities and Local Government (MHCLG).

The MHCLG's Digital Planning Improvement Fund is accepting applications from local planning authorities across England.

The £50,000 grant opportunity will enable local planning authorities to:

- understand your organisation's digital planning maturity to baseline a starting point
- create an action plan to help improve your organisation's digital planning maturity
- identify, prepare and publish planning datasets to the <u>Planning</u> Data Platform
- join <u>Open Digital Planning</u> (ODP), a collaborative community of forward-thinking planning authorities
- access tailored training and improvement opportunities

Applications can be submitted anytime and close at midday on 30 October 2025, with successful applicants starting in February 2026.

A question and answer session is taking place on 20 October at 11.30am to help potential applicants.



The national LLC Register cost savings

Since programme launch, the LLC Register has

- recorded a total cost saving of over £3.4 million from searches in the migrated areas
- saved an average of
 12.35 days to obtain an
 LLC search result
- migrated more than
 7.7 million charges from
 130 local authorities
 to the register.



The national LLC Register – total number of searches

Since July 2018, we have recorded

334,235 total official searches 1.504,472 personal (free) searches 1.838,707 total searches on the register
