- 1. This licence is granted under the UK Autonomous Sanctions Regulations listed in Annex 1 of this licence.
- 2. Any act which would otherwise breach the prohibitions in the UK Autonomous Sanctions Regulations, as listed in Annex 1 of this licence, is exempt from those prohibitions to the extent required to give effect to the permissions in this licence.

3. In this licence:

"News Media Services" means	News reporting and journalistic services by a recognised UK news publisher.
a " Person " means	An individual or a body of persons corporate or unincorporate but does not include a DP.
"the UK Autonomous Sanctions Regulations" means	Those sanctions regulations listed in Annex 1 of this licence.
"Permitted Payments" means	Payments to, from or via a designated person (including a designated Credit or Financial Institution), providing these involve the receipt or provision of News Media Services.
	 Payments include but are not limited to: Rent, utility bills, and fixer charges. Regulatory payments including taxes. Receipt of licensing fees, paid to providers of News Media Services. Payment of salaries, invoices or fees to third parties.
a "Designated Person" means	Those individuals or entities designated (or owned or controlled by an individual or entity designated) for the purposes of an asset freeze by the UK under the UK Autonomous Sanctions Regulations, excluding those designated for the purpose of compliance with United Nations obligations.

"a designated Credit or Financial Institution" means	Any credit or financial institution designated under any of the UK Autonomous Sanctions Regulations.
a "Relevant UK Institution" means	A person that has permission under Part 4A of the Financial Services and Markets Act 2000 (permission to carry on regulated activity).
	A person that is authorised or registered under Part 2 of the Payment Services Regulations (SI 2017/752).
	A person that is authorised or registered under Part 2 of the Electronic Money Regulations (SI 2011/99).
	A person that is a "recognised clearing house", "third country central counterparty", "recognised CSD" or "third country CSD" for the purposes of s.285 of the Financial Services and Markets Act 2000.
	A person that is an operator of a recognised payment system (or that is a service provider in relation to recognised payment systems) for the purposes of Part 5 of the Banking Act 2009.

Permissions:

- 4. Under this licence, subject to the conditions below:
 - 4.1. A person providing News Media Services (and any Person who provides any goods or services to another Person which are necessary for the provision of News Media Services by that other Person) may carry out any activity reasonably necessary to effect the receipt or provision of News Media Services, including making or receiving Permitted Payments.
 - 4.2. A Relevant UK Institution may process payments made in accordance with paragraphs 4.1.

Conditions

5. This licence does not permit payment directly or indirectly to, from or for the benefit of any person designated for the purpose of compliance with United Nations obligations.

Reporting Requirement

- 6. Within 30 days of making or receiving a Permitted Payment a Person must send a report to HM Treasury with details of:
 - 6.1. The purpose of the payment;

- 6.2. The name of the Designated Person (sender, intermediary or recipient of the funds/payment);
- 6.3. The payment amount;
- 6.4. The date on which the funds were transferred;
- 6.5. The payment route;
- 6.6. The relevant UK Autonomous Sanctions Regulations; and
- 6.7. Name of the UK News Media publisher (and parent company where applicable).

Record-keeping Requirements

7. A Person must keep accurate, complete and readable records, on paper or electronically, of any activity purporting to have been permitted under this licence for a minimum of 6 years.

General

- 8. The permissions in this licence do not authorise any act which will result in a breach of any part of the Regulations listed in Annex 1, save as permitted under this or other licences granted under the Regulations listed in Annex 1.
- 9. Information provided to HM Treasury in connection with this licence shall be disclosed to third parties only in compliance with the UK General Data Protection Regulation and the UK Data Protection Act 2018.
- 10. This licence takes effect from 19 September 2025.
- 11. HM Treasury may vary, revoke or suspend this licence at any time.
