The current version of the framework was published in September 2021 by the Department for Levelling Up, Housing and Communities and clarifies what assurances should be in place when administering adult education functions.

In addition, the Department for Education also has an associated Memorandum of Understanding in place with your Combined Authority in relation to the devolution of adult education functions.
