Re: Freedom of Information Act 2000 (FOIA)

Thank you for your email of 22 July 2025 in which you requested from the Insolvency Service (the agency):

“The IS published yearly consumer insolvency figures in February 2025, detailing market share for each participant in the consumer IVA market for the full year 2024. One of the entries is a firm called United Insolvency Limited, where it was stated that this firm registered 1635 IVAs in the full year 2024, we would like to following information:

1. *How many IVA registrations were made by United Insolvency in each individual calendar month from January 2024 to December 2024, for example:*
 - a. *January: 102*
 - b. *February: 135*
 - c. *March: 150*
 - d. *Etc”*

Your request has been dealt with under the Freedom of Information Act 2000 (FOIA).

I can confirm the agency holds the information that you have requested. This information is available to you at the website link below:

This information is available in our monthly statistics publications, specifically in the individual monthly statistics data tables (table 7b, line 30). The figure you quoted in your request of 1635 has since been revised to 1891. This change reflects the transfer of some IVAs to Unit Insolvency Limited from another Insolvency Practitioner firm during the intervening period.

Because this information is reasonably accessible to you the agency is not obliged to provide you with a separate copy of the information pursuant to the exemption at section 21 of FOIA.
