TPO search extent	Where charges including TPOs would have been revealed when searching just the property, now the search spatial extent must also include the frontage of property.	<p>Before: LA revealed additional charges including TPOs that may affect the search.</p> <p>After: For all related charges to be revealed, the search spatial extent should cover the searched property and associated garden or grounds.</p>
Textual data - Charge types and sub-categories	All charges in the Register now contain a charge type and a sub-category in accordance with the HMLR schema.	<p>Before: Inconsistencies in charge-types, sub-categories, instruments, and statutory provisions found.</p> <p>After: Charge type mapping successfully applied to all charges where applicable in accordance with the HMLR schema to show relevant charge-types, sub-categories etc.</p>
Textual data - Addresses	Addresses have been populated for all charges.	<p>Before: Some charges would have no address.</p> <p>After: All charges have an address or a geographic description of the affected land.</p>
Textual data – Part 6 charges	Any expired part 6 charges are removed.	<p>Before: 207</p> <p>After: 0</p>
Spatial data	All charges contain an appropriate geometry.	<p>Before: Not all charges had a geometry or had invalid geometry.</p>
