Under the regulations, slaughterhouses with a throughput of between 1,000 and 1,999 sheep per week as a rolling annual average are not required to classify carcases or register with RPA. However, those slaughterhouses can voluntarily register with RPA and request that the regulations apply to them. Those who register on a voluntary basis will remain registered for a minimum of 12 months and must meet all regulatory requirements during this time.
