Listed Buildings	A change in the way that curtilage is captured for Listed Buildings.	<b>Before:</b> Only the extent for the primary building was captured and manually referred at time of search request to see if curtilage applies <b>After:</b> Listed Buildings have been considered, and the extent now includes the curtilage where applicable
Statutory Provisions	Statutory Provisions were updated to match the HMLR approved statutory provision format.	<b>Before:</b>  Town and Country Planning Act 1971 <b>After:</b> Town and Country Planning Act 1971
Textual data – Personally Identifiable Data	Where personally identifiable data was found in the supplementary information, this has now been removed.	<b>Before:</b> Some charges would have a persons name, telephone number or email address for a customer. <b>After:</b> This data has been removed to adhere to General Data Protection Regulation (GDPR) protocols
Spatial Data	All charges contain an appropriate geometry.	<b>Before:</b> Not all charges had a geometry or had invalid geometry. <b>After:</b> All charges have an appropriate representation of the charge extent.



Textual data - Charge types and sub-categories	All charges in the Register now contain a charge type and a sub-category in accordance with the HMLR schema.	<p><b>Before:</b> Inconsistencies in charge-types, sub-categories, instruments, and statutory provisions found.</p> <p><b>After:</b> Charge type mapping successfully applied to all charges where applicable in accordance with the HMLR schema to show relevant charge-types, sub-categories etc</p>
Textual data - Addresses	Addresses have been populated for all charges.	<p><b>Before:</b> Some charges would only have an address referenced in the description of the charge.</p> <p><b>After:</b> All charges have addresses or a geographic description of the affected land.</p>
Financial Charges	Rate of interest has been populated with a numerical value for all part 2 charges.	<p><b>Before:</b> Some charges did not have a populated rate of interest field.</p> <p><b>After:</b> Rate of interest has been populated with a numerical values for all part 2 charges</p>
Textual data-supplementary information	Where no descriptions of charges were found in supplementary information, this has corrected.	<p><b>Before:</b></p> <p><b>After:</b> Erection of an 8FT fence around the perimeter of property</p>
Creation date	The charge creation date of some charges was found to be inconsistent with the registration date. A decision has been taken to remove the charge creation date up until the final LA extract taken on 2/6/2025	<p><b>Before:</b> Creation date population</p> <p><b>After:</b> Creation will not be revealed</p>
