

EXPORT OF BOVINE DNA FOR RESEARCH USE TO CANADA

NOTES FOR THE GUIDANCE OF THE OFFICIAL VETERINARIAN AND EXPORTER

IMPORTANT

These notes provide guidance to Official Veterinarians (OV) and exporters. The Notes for Guidance (NFG) should have been issued to you together with export certificate 8899EHC. The NFG should not be read as a standalone document but in conjunction with certificate 8899EHC. We strongly suggest that exporters obtain full details of the importing country's requirements from the veterinary authorities in the country concerned, or their representatives in the UK, in advance of each consignment.

1. Scope of the certificate

This certificate covers the export of bovine embryos biopsies for research purposes to Canada.

2. Official Signature

This certificate may be signed by an OV appointed by the Department for Environment, Food and Rural Affairs, the Scottish Government, Welsh Government or the Department of Agriculture, Environment and Rural Affairs (DAERA) Northern Ireland, who is on the appropriate panel for export purposes or who holds the appropriate Official Controls Qualification (Veterinary) (OCQ(V)) authorisation.

OVs should sign and stamp the health certificate with the OV stamp in any colour **OTHER THAN BLACK**.

Certified Copy Requirements – England, Wales and Scotland

Guidance concerning return of certified copies of EHCs has changed and only specific certified copies are required to be returned to the APHA. Certifying OVs must return a certified copy of EHCs only for the following EHC types:

- if the exported commodity is cattle, pigs, sheep, goats or camelids;
- if the certificate was applied for manually and the application documents have been emailed to APHA and not applied for via the Exports Health Certificates Online (EHCO) system.

Certified copies should be emailed on the day of signature to the Centre for International Trade Carlisle (CITC) at the following address: certifiedcopies@apha.gov.uk.

For certificates that have been issued to the Certifying OV via the EHCO system, the Certifying OV must complete the certifier portal with the status of the certificate and the date of signature.

A copy of all EHCs and supporting documentation certified must be retained for two years.

Certifying OVs are not required to return certified copies of other EHCs issued, however CITC may request certified copies of EHCs and supporting documentation in order to complete Quality Assurance checks or if an issue arises with the consignment after certification.

DAERA Export Health Certificates: provision of certified copies

Authorised Private Veterinary Practitioners (aPVPs) certifying DAERA Export Certificate System (DECS) produced EHCs must return a legible, scanned copy of the final EHC to the relevant DAERA Processing Office within 1 working day of signing.

Good quality photographic copies will be accepted by the Department where obtaining a scanned copy is not feasible - for example, where

'on site' certification is undertaken and scanning facilities are not available.

For record purposes, a copy of the final Export Health Certificate and associated Support documents should be retained by the aPVP for a period of 2 years from the date of certification.

The Department will carry out periodic audits of all aspects of export certification to ensure that a high standard of certification is being maintained.

3. **Import Licence**

Exporters are responsible for ascertaining whether an import permit is a compulsory requirement in the importing country, and if so, for ensuring that they, or the importer in case of transfer of ownership, have obtained the necessary permit.

4. **Certification**

- IV (a) may be certified on the basis of documentation or evidence as deemed necessary by the OV alongside the OV's knowledge of handling, processing, packaging storage and transportation procedures in place at the establishment
- IV (b) may be certified on the basis that at the time of collection of the materials to be exported, the UK is recognised by Canada as free from the listed diseases. This must be confirmed on CFIA's public list at <https://inspection.canada.ca/en/animal-health/terrestrial-animals/diseases/status-country/united-kingdom> .

If the embryo collection date is before the latest update date shown on CFIA's list please contact CIT.

- IV (c) may be certified on the basis that the material being certified is derived from bovine embryos, and the certifying officer is confident that the material is not contaminated in any way with the specified risk material listed in the certificate.
- IV (d) may be certified on the basis of the OV's knowledge of handling, processing, packaging storage and transportation procedures in place at the establishment

5. **Disclaimer**

This certificate is provided on the basis of information available at the time and may not necessarily comply fully with the requirements of the importing country. It is the exporter's responsibility to check the certificate against any relevant import permit or any advice provided by the competent authority in the importing country.
