Chair's welcome

Minutes of the previous meeting were approved. The following potential conflicts of interests relating to the day's agenda were declared by the membership:

- Mark Mon-Williams has had discussions with ESRC about a potential project for the R&D Missions Program (RDMP)
- Rose Luckin has been invited to join the DfE Task and Finish Group on Al and EdTech, which is linked to the Curriculum & Assessment Review. She is also working with the Al Security Institute.
- Paul Ramchandani is a member of the Foundations What Works Centre for Children and Families.

Athene Donald informed the membership that she has joined the Opportunity Mission Expert Reference Group (OMERG) *ex officio*, which held its first meeting on 3 April 2025. The discussion focused on Attendance and Place.

Introduction from Sir Kevan Collins, Lead Non-executive Director to DfE

Sir Kevan Collins is the lead non-executive director of the DfE board. He emphasized his commitment to evidence-based policy and practice in education. He highlighted key issues such as inclusion, the role of technology in education, family engagement, and the importance of post-16 non-academic routes for economic growth. He emphasised his desire for the SAC to provide friendly challenge to the DfE.

Update from the DfE Chief Scientific Adviser (CSA), Russell Viner

The CSA provided an update on various workstreams and areas of interest within the department:

- **Opportunity Mission and R&D**: Finalizing R&D returns for the Spending Review and coordinating SR bids with other CSAs and GCSA.
- **SEND&AP**: Supporting the development of DfE's reform to the SEND&AP system.
- Children's Wellbeing and Mental Health: Investigating the impact of smartphones and social media on young people and advising on anti-bullying initiatives.
- **Health**: Supporting the DfE team engaging with the COVID Inquiry and collaborating on the Adolescent Health Study.
- Skills: Discussing Skills and Opportunity Mission with the Council for Science and Technology and co-chairing a group on Economic Inactivity and Health in Young People.
- Other Initiatives: Advising GO Science on the Future of Childhood foresight project, focusing on data and digital initiatives.

ACTION 3.1: SAC Secretariat to organise for the Future of Childhood team to present to the SAC.

Brief roundtable updates on relevant DfE work

- **SEND:** Mark Mon-Williams gave evidence to the House of Lords in relation to the Autism Act 2009.
- **Opportunity Mission:** Claire Crawford has joined the expert advisory group for Best Start in Life with DfE, which overlaps with the SAC's work on SEND.
- Young people Not in Education, Employment or Training (NEET): Dougal Hargreaves is working with the People's Health Trust on a national project to support young people with mild to moderate mental health difficulties.
- **Health:** The SAC discussed the dissolution of NHS England and the importance of considering programs for children's health wholistically, rather than being part of wider, separate policy on health issues (e.g. obesity, mental health etc).

Skills England

The Chair invited the membership to discuss the work of the SAC. The conversation focused on the need to prioritise work areas. The Membership discussed the importance of setting clear questions in advance to make discussions more productive and actionable. There was also a suggestion to have written outputs with a request for policy teams to respond formally, ensuring that insights drive policy changes effectively.
