The Norfolk Vanguard Offshore Wind Farm Order 2022 (SI 2022 No. 138) as amended by the Norfolk Vanguard (Amendment) Order 2023 (2023 No. 1390) (“DCO”)

Application for amendment of the Generation and Transmission Deemed Marine Licences pursuant to Section 72(3)(d) of the Marine and Coastal Act

Pursuant to our change request sent on 12th March and on further inspection, an additional amendment is requested to the Vanguard DML.

Norfolk Vanguard Limited changed its name on 30 September 2023 to Norfolk Vanguard West Limited. A copy of the certificate of change of name issued by Companies House is attached for your information. An amendment is requested to apply to the following dMLs under the Vanguard DCO only.

- Schedule 9 – deemed marine licence for phase 1 in respect of the generation assets;
