Dear Jemimah,

The EMS update is attached. We would point out that it is almost impossible to comply with your notice without closing the wash plant and making staff redundant. The only reasonable way of stating that case is by appealing the notice as the Agency has undertaken a complete U-Turn in the way it regulates the site over the last year or so and has not responded fully to the permit holder's concerns. The appeal deadline is 29/09/24. An appeal will be submitted for a hearing or enquiry procedure before that date.
