Item 1: Welcome and Introductions

- 1. RM welcomed attendees to the meeting
- 2. RM informed the group that KK has been appointed a Member of the Order of the British Empire (MBE) for services to ecology, forestry and woodland management. The group congratulated KK on this well-deserved achievement.

Item 2: Review Minutes From Previous Meeting

3. The minutes from the last meeting were agreed and the actions were reviewed

Item 3: Updates from Defra

4. ID gave a short update on Defra priorities, as DD and DE were unable to attend the meeting.

Item 4: Tree Target Benefits Modelling Paper

- 5. GW presented the current approach to modelling benefits from tree planting for the statutory tree target. The group broadly agreed that the high-level modelling was appropriate for current use.
- 6. TaWSAG recognised the limitations of the analysis for spatial prioritisation or other targeting applications. Whilst TaWSAG endorsed the use of average values as appropriate for the current uses of the modelling work, it was recognised that this approach could not support site-level targeting.
- 7. TaWSAG encouraged the Defra Forestry team to ensure integration with ongoing Defra Farming and Countryside Programme (FCP) work.
- 8. TaWSAG recognised the analysis as being conservative with the risk that it may underestimate benefits from trees.

Action 1: TAW-SAG members to email comments on the modelling paper directly to GW.

Action 2: GW to integrate feedback and explore whether outputs from Liverpool John Moores University can improve modelling precision.

Item 5: Water-Related Tree Benefits – Scoping Review (presented by CM on behalf of TL)

- 9. CM introduced TL's work to scope evidence on how tree planting influences water outcomes. The group welcomed the focus but suggested further clarity on aims and approach (literature vs. empirical data vs. knowledge mapping).
- 10. TaWSAG noted the importance of linking to ongoing work including work supporting Defra's Farming and Countryside Programme.
- 11. TaWSAG recommended that carrying out analysis to support spatial prioritisation of woodland creation with respect to water benefits was too big a challenge for a Fellowship role and approved of the proposal for TL to act as a bridge between the wide range of ongoing research work and Defra policy, particularly regarding evidence gaps and horizon scanning.

Item 6: Tree Cover Target Adjustment

- 12. ID and GW confirmed that the Defra trees team has passed on the support of TaW-SAG in the advice to ministers.
- 13. GW updated on ongoing work to boost private finance for woodland creation, including engagement with the Emissions Trading Scheme team in DESNZ.
