Monthly Summary

- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of air quality and dust monitoring undertaken in the London Borough of Camden (LBC) during July 2025 and August 2025 respectively.
- 1.1.2 Figure 1 to Figure 5 in Appendix A present the current worksites together with air quality and dust monitoring locations.
- 1.1.3 This summary should be read in conjunction with the overview monitoring report available from www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2, which highlights: the applicable standards and guidance, as well as the air quality and dust monitoring methodologies to be implemented by nominated undertakers throughout construction.
- 1.1.4 The current worksites, as presented in Appendix A, Figure 1 to Figure 5, include:

Skanska Costain STRABAG Joint Venture (SCS JV)

Adelaide Road Vent Shaft

- Works currently paused until April 2027.

Euston Scissor Cut

- Limited groundworks, concrete works and materials management.

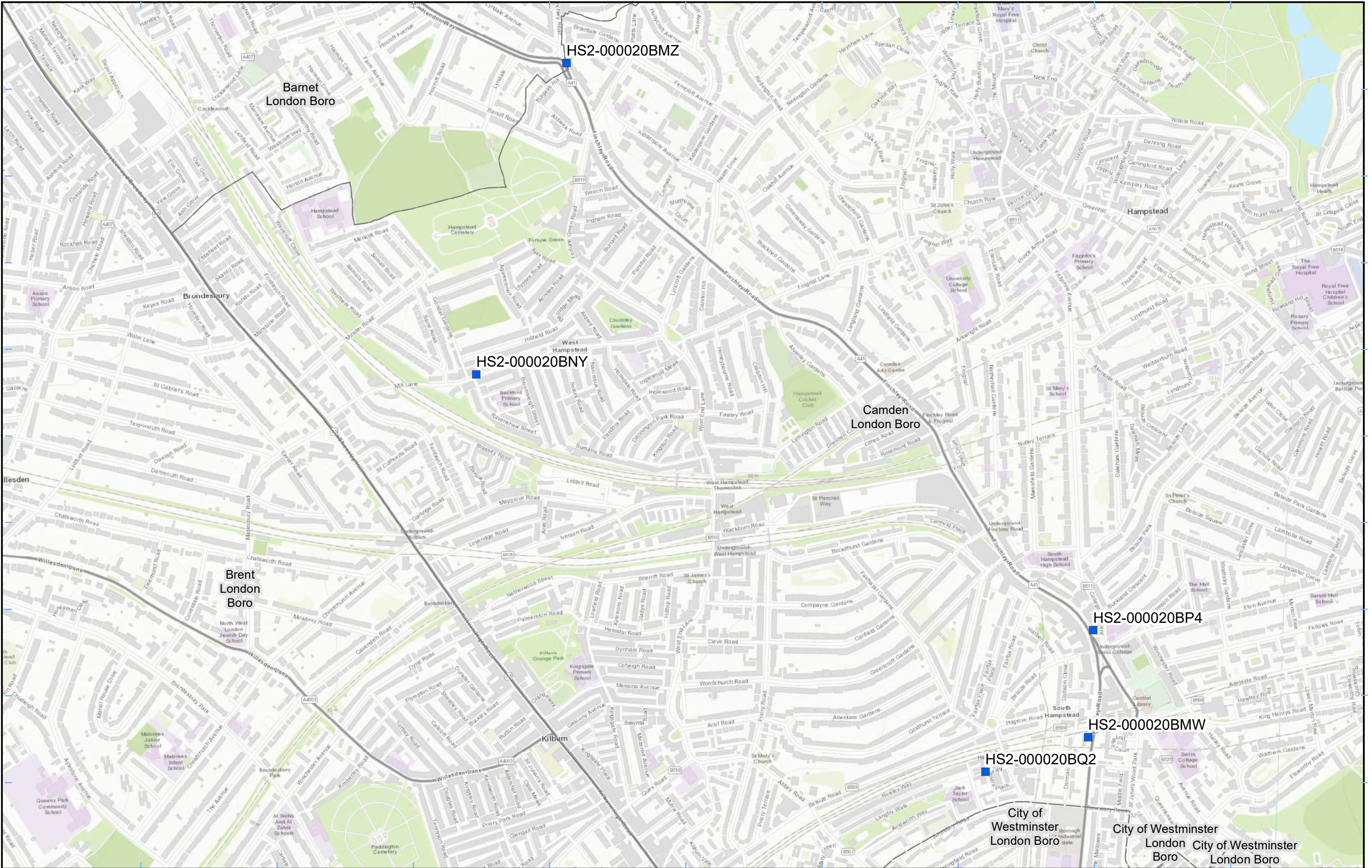

- Wingate – Commenced ATS power supply on MET line at Euston Square
- Delatim – Commenced repair works on Tranche 4 intrusive survey works. Works taking place in Euston station.

- 1.1.5 Twenty (20) dust monitors are installed around these worksites, where works are underway. These sites returned a medium to high dust risk rating.

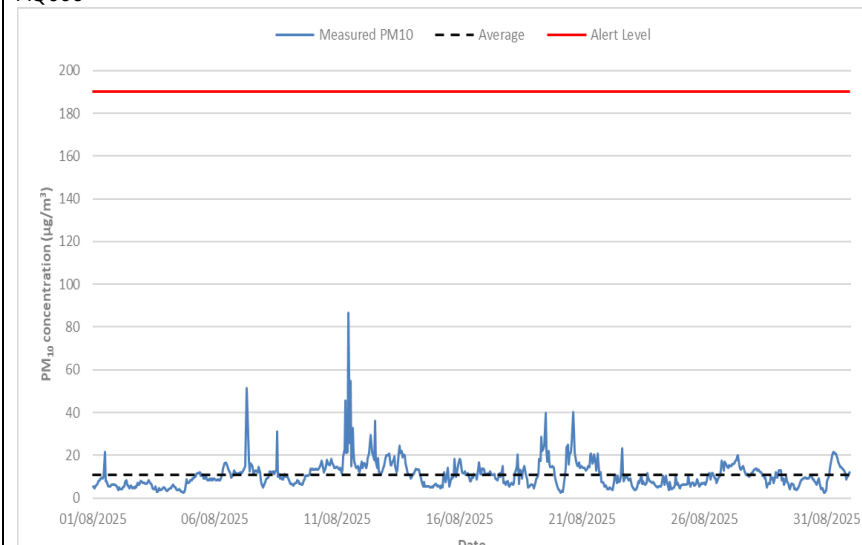
Figure 6: Construction dust 1-hour mean indicative PM₁₀ concentration for all dust monitors

- 1.1.6 Dust monitoring locations and results are presented in Appendix B, Table 1, together with line charts of monthly data from each dust monitor in Figure 6. All continuous dust monitoring is undertaken using indicative monitors. Despite being Environment Agency (MCERTS) certified, indicative monitors carry a higher level of uncertainty than reference monitors, and therefore cannot be strictly compared with Air Quality Standards for human health and the environment. The purpose of the monitoring undertaken is to ensure the effectiveness of the on-site mitigation.
- 1.1.7 The trigger level for PM₁₀ concentrations of 190 µg/m³, over a 1-hour period, in accordance with the updated guidance document '*Guidance on Monitoring in the Vicinity of Demolition and Construction Sites – (October 2018)*' has been applied.
- 1.1.8 No (0) dust trigger alerts were recorded during the monitoring period (August 2025).
- 1.1.9 Data capture was below 90% for multiple monitors due to:
- AQ004 and AQ010 - air flow errors from the previous monitoring period which were resolved on 13/08/2025.
 - No data was recorded at AQ009 during the monitoring period due to ongoing airflow errors with this unit. It has not been possible to fix the faults remotely; thus, the monitor has been sent off for repair and will be reinstalled during the next monitoring period.
 - AQ020 - it was observed that concentrations were very low at the start of the monitoring period (likely because this monitor was approaching its recalibration date, although no error alert was received). This monitor was therefore sent for recalibration on 13/08/2025 and will be reinstalled during the next monitoring period.
 - AQ054 - arrangements for a 3rd party contractor to isolate the CCTV column on which the monitor is mounted in order for it to be replaced have not yet been agreed. The currently installed monitor is no longer operating. The monitor should be replaced in September 2025.

- 1.1.10 Diffusion tube monitoring of Nitrogen Dioxide (NO₂) is undertaken at sixty-four (64) locations around highways within the LBC as part of the management of air quality where significant effects may occur as a result of the scheme.
- 1.1.11 Diffusion tube monitoring results are as provided from the laboratory analysis, and therefore still require various analysis and adjustments to be undertaken. Final corrected results will be presented and described in the annual report. However, based on the results to date, no unexpected values were recorded during the monitoring period.
- 1.1.12 NO₂ monitoring locations and results are presented in Appendix C, Table 2, together with the 2025 running mean.
- 1.1.13 There were no (0) complaints received during the reporting period (August 2025).

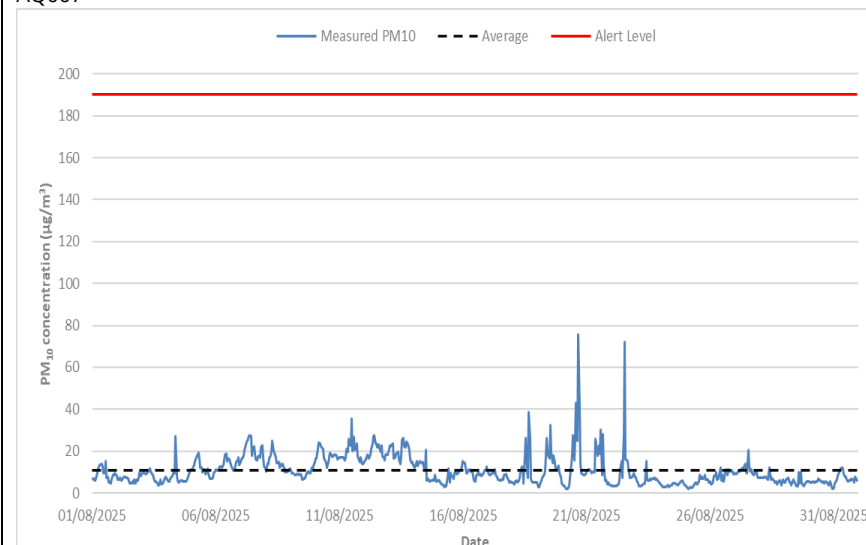
