## North Yorkshire and North Humberside

## Establishing a new academy through the free school presumption route

Project: A proposal for a sponsor for Harrogate Special Presumption Free School, URN TBC, North Yorkshire.

#### Representations received:

• No representations were made for this project.

#### AB discussion:

- Harrogate Special Presumption Free School will have a capacity of 80 pupils between 11-19 years of age with the primary need of Autism, Speech, Language & communication and associated mental health needs and be located in North Yorkshire.
- Officials' assessment of the trust using the Commissioning High Quality Trusts
   Framework was considered alongside the strategic need for Special School places in
   the area. In making the recommendation, consideration was given to the trust's
   experience in successfully running a similar provision since 2012 and the existing
   positive relationship with the Local Authority.
- Board members agreed that the trust was a good choice to sponsor the new school, however, recommended that further discussions take place to agree an opening date
- Schools Funding and Strategic Oversight (SFSO) colleagues recommended the deployment of a School Resource Management Advisor (SRMA) to the trust post conversion.
- Board members recommended a review of Governance and mentoring from a Trust who have been through a similar process.
- As a condition of approval, funding should be agreed by all parties to assure long term sustainability through opening.

   existing strengths of the school and the strong working relationship with the Peak
   Edge Trust who operate the infant school.
- Schools Funding and Strategic Oversight (SFSO) colleagues recommended the deployment of a School Resource Management Advisor (SRMA) to the trust post conversion.
- Board members agreed the match, but recommended the addition of another Member to the Trust Board and that the audit committee should be separated from the finance committee to strengthen governance at the trust.
